**CALL TO ORDER
AND
ROLL CALL**

Superintendent Barresi called the State Board of Education regular meeting to order at 9:43 a.m. and welcomed everyone to the meeting. Ms. Isenhour called the roll and ascertained there was a quorum.

STATE SUPERINTENDENT

Information from the State Superintendent

Superintendent Barresi gave updates on damage of May tornadoes and storms, school district relocation and rebuilding plans, student relocations/emergency transfers, legislative per pupil funding protection assessments, district impact future disasters, continuous assistance; Project Meet the Need launch/website, Red Cross/United Way/Feed the Children organizations, teaching certificate fee waivers; VISION2020 Conference, media communications, Governor's office, FEMA, Land Commission allocations, federal program waivers, and C³ Grant Pool and process.

Employee Service Recognitions

Superintendent Barresi presented Ms. Vonna Anderson a recognition certificate and service pin from Governor Mary Fallin and the State Department of Education for 35 years of dedicated service to the citizens of Oklahoma.

**Recognition of Union Public Schools, Independent District #9,
for receiving the National Association of Music Merchants
Foundation Designation of Best Communities for Music Education**

Superintendent Barresi recognized and commended Ed Tackett, Director of Fine Arts, and Matthew McCready, Assistant Director at Union Public Schools on receiving the National Association of Music Merchants (NAMM) Foundation the Best Communities for Music Education. Superintendent Barresi said the United States Army's eCYBERMISSION Award competition is a national Science, Technology, Engineering and Mathematics (STEM) competition. It is designed to inspire student interest in STEM subjects, challenge students in grades 6 through 9 to develop solutions to real-world problems in their local communities. Superintendent Barresi recognized two Oklahoma City Public Schools District educators for outstanding commitment to education, and involving the community and parents in innovative programs. Jae Strickland, Principal, Hayes Elementary was honored for her outstanding accomplishments. Mrs. Annetta McCoy, Counselor, US Grant High School, for her 25-year career as an educator positively influencing the lives of children.

**Recognition of Think Through Math Students and
their Charitable Actions for the May Tornado Victims**

Superintendent Barresi recognized and thanked students in Oklahoma and across the nation for participating in the Think Through Math program by donating dollars to help tornado victims. Students earned points by solving math problems and \$1 for completing 400 problems. Emily Robertson, Think Through Math-Norman requested the company designate the Central Oklahoma Chapter of the American Cross and they matched student's donations up to \$5,000. The student donations totaled \$6,720, and with the Think Through Math match an \$11,873 check was presented to Jake Peters, Regional Development Officer, Red Cross of Central Oklahoma.

TEACHER CERTIFICATION

Teacher Certification Production Report

Superintendent Barresi said Mr. Jeff Smith, Executive Director, Teacher Certification, is present to answer questions from the Board, if needed.

This was a report only and no action was required.

ACADEMIC AFFAIRS

Office of Educational Support

Teacher and Leader Effectiveness (TLE) Report

Superintendent Barresi said Ms. Kerri White, Assistant State Superintendent, is present to answer questions from the Board, if needed.

Superintendent Barresi said the federal TLE implementation delay request did not take flexibility away. The change in state legislation was related to reviewing the importance of a complex program, implementation, and was done very well. It was decided that the first year implementation would be 2014-2015, and the first year decisions will be made for human capital is 2015-2016. Arne Duncan, Secretary of Education, submitted an opportunity for two waivers for states to apply. One for implementation of TLE for human capital hiring and firing decisions only was not a waiver for implementation of the program. The Legislature made the appropriate decision that was best for Oklahoma therefore no need to apply for a waiver.

Ms. White said the teacher feedback survey of the report was specific about the Oklahoma process, in response to Board Member Baxter's question.

This was a report only and no action was required.

**Request For Proposals (RFPs) Submitted Pursuant to the State
Board of Education's Competitive Grant Pool Program.
(Oklahoma C³ Competitive Grant Pool Program: Solicitation #:2650000247)
Approved**

Ms. White presented components of the request for proposals that through direct services to students or through services to teachers, administrators or stakeholders, the Oklahoma C³ Competitive Grant Pool recipients will impact the College, Career and Citizen Readiness of Oklahoma students.

Mr. Keith Hicks, Purchasing Director, said the purpose of not disclosing information through the selection process is to protect the integrity of that selection process without the risk of protest. The Administrative Code Central Purchasing rule 580, section 16-7-32d restricts agencies from any disclosure during the selection pre-award process until the State Purchasing Director approves the award of a contract. Once the SBE approves the recommendations, awards will be made this afternoon.

Board Member Ford made a motion to approve the grant pool award requests to RFP-1 \$75,000; RFP-2 \$70,000; RFP-3 \$275,000; RFP-4 \$50,000; RFP-5 \$125,000; RFP-6 \$1,000,050; RFP-7 \$50,000; RFP-8 \$200,000; RFP-9 \$445,000; RFP-10 \$185,000; RFP-11 \$114,000; RFP-12 \$86,000; and RFP-13 \$75,000; which totals \$2.8 million appropriation.

Board Member Baxter seconded the motion. The motion carried with the following votes: Mr. Shdeed, yes; Mr. Price, yes; General Baxter, yes; and Ms. Ford, yes.

Board Member Ford made a motion directing the SDE to review any current RFPs relating to the use of federal funds, and to hold purchase orders to determine whether vendors receiving contracts as a result of the SDE process today are participating in a concurrent RFP process that may result in a collusion or supplanting issue.

Office of Accountability and Assessments

**Standards Setting Results and Performance Level Descriptors
for OCCT and OMAAP Biology I EOI Assessments Approved**

Ms. Maridyth McBee, Assistant State Superintendent, Office of Accountability and Assessments, presented requests recommending new cut scores for Biology I which was the end-of-instruction (EOI) regular test and modified assessment. Content standards in all subjects are periodically reviewed, per the law, every six years but often times more frequently. Ms. McBee reviewed the standard setting results, performance level descriptors, EOI assessments; and AP test comparisons and changes.

Board Member Ford made a motion to approve the requests and Board Member Shdeed seconded the motion. The motion carried with the following votes: Mr. Shdeed, yes; Mr. Price, yes; General Baxter, yes; and Ms. Ford, yes.

C³ Schools

Proposed C³ Partnership Schools Approved

Mr. Richard Caram, Assistant State Superintendent, School Support and C³ Schools, presented a request recommending C³ partnership from Cohort 1 to Cohort 2 status that included:

Wewoka High School; Kenwood Public School; Mannsville Public School; McLain Junior High School and Burroughs Elementary School-Tulsa Public Schools; Marcus Garvey Leadership Charter School, Bodine Elementary-Oklahoma City Public Schools; Graham High School-Graham Public Schools and Dustin Elementary-Dustin Public Schools.

Mr. Caram reviewed selection processes; district capacity determination (DCD) reports/scoring, site background, historical data submission, collaboration teams, scorings, SBE authorities, and school leadership and evaluations.

Responding to Teacher and Leader Effectiveness (TLE) superintendent evaluation question, Ms. Kerri White said the law does not require school boards to use the TLE system to evaluate a superintendent. Some districts use the McREL or Marzano Leadership frameworks which are designed to evaluate and review superintendent's performance or use similar rigorous models not approved for and not designed for principals but have similar requirements of superintendents. The percentage data has been collected on the number of school boards using these. School districts could be asked to share their evaluation processes if they are interested in doing so.

It cannot be discussed because it is a separate RFP process but was very important under the agenda item to address in order to cover all bases.

Board Member Shdeed reported Dr. Ramona Paul had suffered a stroke. Superintendent Barresi said Dr. Paul is the pioneer that made early childhood education possible for the state of Oklahoma. She was tireless in her efforts and is part of her legacy, professionally and personally. We recognize all her contributions to the profession and our continued prayers for her ongoing improvement.

Superintendent Barresi said the list of out of town SBE meetings will be provided at the July 25, 2013 meeting.

PUBLIC COMMENT

The final public comment period had several individuals signed up; however, Superintendent Barresi called the SBE and public's attention to the descriptor on the Public Comment Sign-in forms "for the qualifications to be able to speak" under public comment for this current meeting do not qualify under those items.
