
Lindsey Nicole Henry Scholarship

I am the Head of School at Stonebridge Academy in Okmulgee, OK. We are a private Pre-K through 8th grade school.

I would like to request the ability to offer the Lindsey Nicole Henry Scholarship at Stonebridge. We are the only private school in Okmulgee and the surrounding area and would like to offer students with IEPs another option for their family.

Currently we offer and/or coordinate a variety of services for our students with special needs, including:

- Assessment and services for any student referred by Stonebridge Faculty for Speech or Occupational Therapy.
- Behavioral health services available to families of Stonebridge at little or no cost through Creoks Behavioral Health Services.
- One-on-one assessment in personality, aptitudes and interests for students in grades 5 through 8 through an AmeriCorps Grant.
- Teacher training and support for students with Autism/Asperger.
- Student Improvement Plans tailored specifically to each student to address and help remediate any individual needs.
- One-on-one tutoring for students after school by teaching staff.
- Summer school program with individualize programs for students in math and reading.

In March the accreditation team from AdvancEd, visited our school. The team recommended to the National Board that we receive accreditation. The National Board met in June and officially granted our accreditation. I am including the accreditation certificate.

I would like to request that you certify our ability to accept the Lindsey Nicole Henry Scholarship.
