Howe	LeFlore* (2)	210: 35-5-71& 210: 35-9-71	Use Library Media Specialist, who is the Gifted and Talented teacher, to oversee the library, which will be operated by a full-time aide.	2
Indianola	Pittsburg* (2)	210: 35-5-71& 210: 35-9-71	Use Library Media Specialist one hour per day and one full-time aide	2
Norman Dimensions Academy	Cleveland* (4)	210: 35-9-71	Use Library Media Specialist 60 hours per year with a full-time aide.	3
Pawnee	Pawnee* (3)	210: 35-5-71& 210: 35-9-71	Use one full-time Library Media Specialist and one full-time aide to operate two libraries with each serving one half time at each library.	1
Perry	Noble* (3)	210: 35-5-71& 210: 35-9-71	Use a full-time Library Media Specialist to oversee two libraries, with two full-time aides at the jr. high/high school library and one full-time aide at the elementary library.	1

At least a half-time certified library media specialist (librarian)

At least one full-time certified library media specialist (librarian) or a half-time certified library media specialist (librarian) and a full-time library assistant.

500-999

At least one full-time certified library media specialist (librarian) and a half-time library assistant

(2) OPTION B.

ENROLLMENT

QUALIFIED SPECIALIST REQUIRED

Fewer than 300

At least one-fifth time certified library media specialist (librarian) and a full-time library assistant.

300 to 499

At least a half-time certified library media specialist (librarian) and a full-time library assistant.

500 +

At least one full-time certified library media specialist (librarian) and a half-time library assistant.

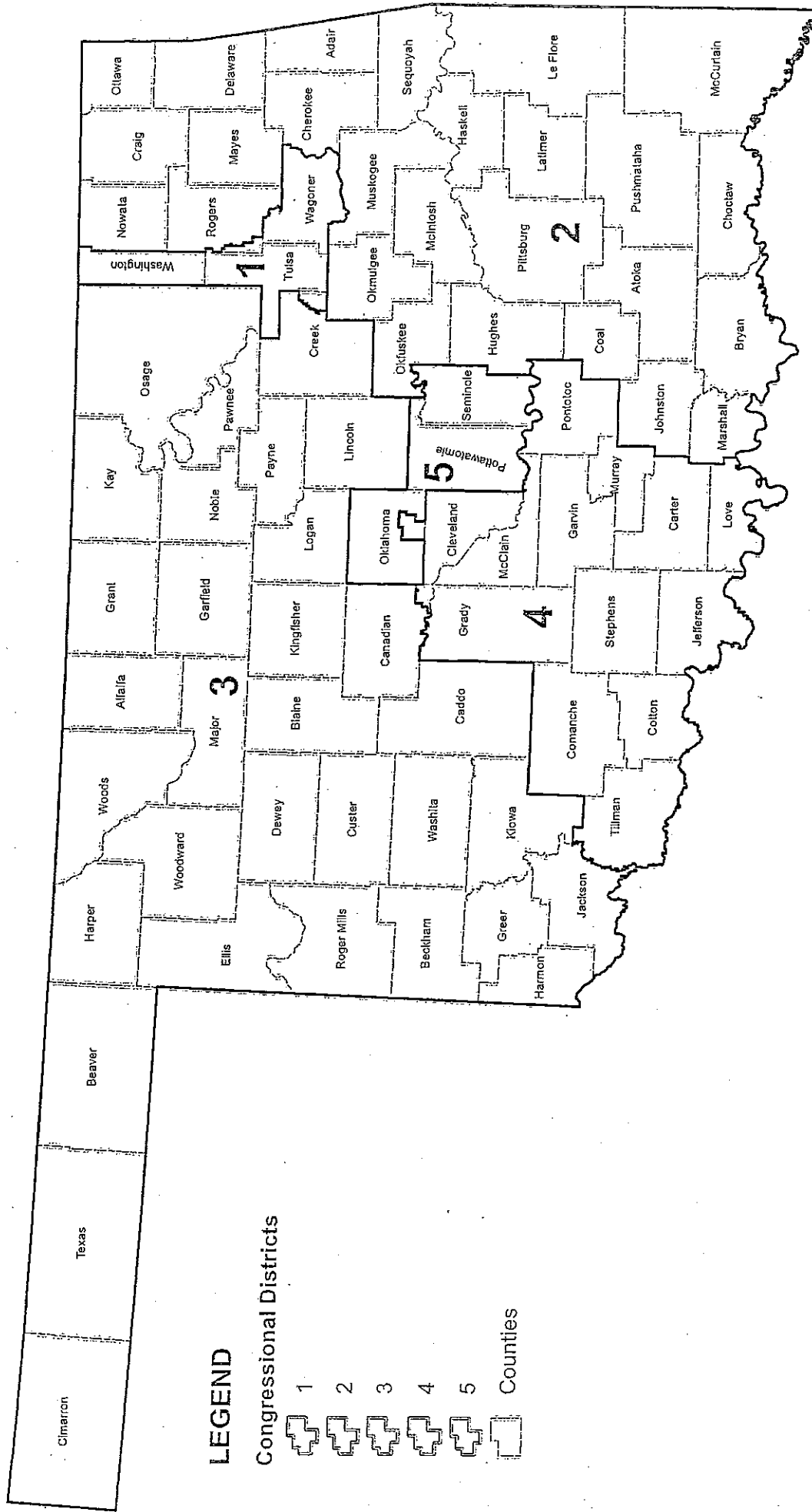
