

RULE IMPACT STATEMENT

TITLE 210. STATE DEPARTMENT OF EDUCATION CHAPTER 10. SCHOOL ADMINISTRATION AND INSTRUCTIONAL SERVICES SUBCHAPTER 3. CHILD NUTRITION PROGRAM

- a. **What is the purpose of the proposed rule change?**
The purpose of the proposed new rule at 210:10-3-112 is to update the State Department of Education's nutrition standards to reflect updates to federal guidance that went into effect on July 1, 2014, and a new State Board of Education policy based on the revised guidelines. The Smart Snacks in School nutrition standards are based on the USDA's new content requirements for snacks sold in schools, and also articulate an exemption policy approved by the State Board on October 17, 2014, to permit school sites to hold limited fundraisers that are exempt from the nutrition standards.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**
The proposed changes will affect public school districts and public schools, as well as public school students. The agency does not anticipate any additional costs to result from the rule amendment.
- c. **What classes of persons will benefit from the proposed rule change?**
The proposed changes will benefit public school districts and public schools, as well as public school students.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**
