The notice must be posted in prominent public view at the principal office of the public body or at the location of the meeting if no office exists. The notice must include the date, time, place, and agenda. Posted agendas required pursuant to the provisions of state statute shall identify all items of business to be transacted by a public body at a meeting. The State Board of Education complied with all posting and notification requirements. This agenda has been modified with respect to certain information contained within Action Item #5 to comply with current ACE Appeal Case processing procedures implemented by the Department.
