CALL TO ORDER AND ROLL CALL

Superintendent Barresi called the State Board of Education special meeting to order at 1:40 p.m. and welcomed everyone to the meeting. Ms. Holland called the roll and ascertained there was a quorum.

PLEDGE OF ALLEGIANCE, OKLAHOMA FLAG SALUTE, AND MOMENT OF SILENCE

Superintendent Barresi led Board members and all present in the Pledge of Allegiance to the American Flag, and a salute to the Oklahoma Flag, and a moment of silence.

OPENING COMMENTS BY STATE SUPERINTENDENT

Superintendent Barresi thanked Board committee members for reviewing the applications for the General Counsel position. She suggested each member share their evaluation system used to review.

Board Member Gilpin said he based his evaluation on the applicant's level of legal experience, background in education or government, and administrative experience.

Board Member Mabry said the three criteria she based her evaluation on were focus on service, minimum five years experience in the legal profession and history/experience with state government.

Board Member Rozell said he based his evaluation on service performed, number of years of experience, and a background in education.

Superintendent Barresi said Ms. Kay Harley, former State Department of Education Legal Counsel, had advised to also look for experience/range in litigation and background in education law. In the absence of an education law background the applicant must be a very good litigator.
