1.	The bid requires all attachments to be two pages or less. However, Attachment 4 requires us to attach a redacted prior proposal. Should Attachment 4 be more than 2 pages and include a full/actual proposal, or should we limit Attachment 4 to two pages and just include the budget and one page summarizing key information associated with the proposal? A. Attachment 4, a redacted proposal, may be more than 2 pages.
2.	<ul><li>Has funding been reserved or a budget been allocated for this project as of yet?</li><li>A. Since no award will be made, no funding has been reserved or budgeted.</li></ul>
3.	If the RFI does proceed to an RFP is there a timeline that the department is hoping to follow in regards to an RFP release? A. The RFI will not proceed to an RFP.
