## Message from State Superintendent Joy Hofmeister

"As this is my final State Board of Education meeting in my official capacity, I want to convey what an honor and a privilege it has been to serve as your State Superintendent of Public Instruction. There have been many amazing experiences throughout my eight years in office, times that I will cherish forever, but none more so than the many opportunities I've had to visit our classroom teachers. These visits never fail to inspire and inform. Your voices are critical if Oklahoma hopes to create and maintain a public education system that our children and families deserve.

But Oklahoma needs to do more than merely listen to our teachers. Teacher flight remains a crisis that calls for a multifaceted approach. Competitive pay is not the only remedy but is certainly part of any long-term fix. I am proud that during my terms in office an overwhelming majority of the state Legislature enacted two long-overdue teacher pay raises. Nevertheless, teacher pay is a moving target, especially in an environment where Oklahoma is competing against other states. Recent pay increases in Colorado, New Mexico, and elsewhere underscore the need for another teacher pay raise next legislative session if we have any hope of turning around the teacher shortage. Oklahoma's commitment to education should be consistent and incremental.

Let's be real. Public education in Oklahoma will not be where we want it to be—where students and families deserve it to be—in a single year, or even three or four. The challenges are formidable in the wake of insufficient per-pupil expenditures, a diminishing teacher pipeline, childhood trauma and the staggering (and still unfolding) repercussions of the COVID pandemic.

But I am optimistic, and you are largely the reason. Oklahoma's teachers are doing incredible things in the classroom each day to help our kids reach their full potential. You devote countless hours, invest the energy, and work hard, often under challenging circumstances, to make meaningful connections with your students and meet them where they are. You are the bedrock of public education in Oklahoma. You are heroes. All Oklahomans owe you a debt of gratitude, and so much more.

As I embark on my next chapter, please know that I remain committed to doing my part to ensure Oklahoma's brightest days lie ahead. And I will always champion you and your work. God bless you all!

Board member Monies moved to approve Consent Docket, agenda item #6. (a)-(e). Board member Williams Bradley seconded the motion. The motion carried with the following votes: Mr. Smith, yes, Ms. Williams Bradley, yes; Ms. Hernandez, yes; Ms. Lepak, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

Superintendent Hofmeister recognized Board member Bobek's family members attending the meeting, wife Tony and daughter Jordan.

#### LEGAL SERVICES

Update, discussion, and possible action regarding Western Heights Independent School District, including the terms and conditions of State Intervention, as determined on July 12, 2021 – Approved

Mr. Clark reviewed the April 2021 action of the SBE placing Western Heights Independent School District on accredited with probation and given a 90-day corrective action; suspended/revoked certificates of former Superintendent Mannix Barnes, SDE Monty Guthrie placed as interim superintendent; an intervention plan adopted July 2021; August 2021 received Writ of Mandamus from Oklahoma County District Court Judge the

Honorable Judge Timmons, removal of Mannix Barnes and most recently school board Attorney; hired Brayden Savage as interim superintendent; Governor appoints new board member after three members abrupt resignations.

Mr. Clark and board members congratulated Superintendent Brayden Savage, thanked SDE team members Monty Guthrie and Ryan Pieper for their dedication to the kids in the Western Heights community; compliments and appreciation to SBE member Trent Smith assisting Governor with candidate interviews and appointment process; and phenomenal litigation job by the SDE legal team.

Mr. Clark recommended to lift the Western Heights intervention according to agenda language. The Western Heights new legal counsel, who was retained Monday night December 12, requested lifting the intervention. Travis Jett, General Council, State Board of Education, concurred and advised that the agenda language is focused just on intervention and not the accreditation status which will be determined later.

Brayden Savage, Interim Superintendent, Western Heights Public Schools, said a lot of work needs to be done in the district but looks forward to making positive changes in Western Heights. New member, Mr. Johnson, was unable to attend but would attend a future meeting. Updates will be provided as they are now a part of her calendar for life! She appreciates all the SDE/SBE support and trusting the district to move forward.

Board member Smith moved to approve lifting the sanctions and new council leadership to be able to make the best decisions. Board member Monies seconded the motion. The motion carried with the following votes: Mr. Smith, yes, Ms. Williams Bradley, yes; Ms. Hernandez, yes; Ms. Lepak, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, yes.

# Monthly report on complaints filed, and status thereof, regarding alleged violations of 70 O.S. § 24-157 and Administrative Code Rule 210:10-1-23, prohibiting race and sex discrimination

Brad Clark, General Counsel, State Department of Education, said on agenda item 7. (c). there were no additional complaints and no additional information from school districts about complaints being field.

# Issue Notice of Proposed Termination on the State Board of Education's sponsorship of Sovereign Community School - Tabled

Ms. Clark updated, reviewed and board members discussed and asked questions regarding the 2019 Sovereign Community School state sponsored charter school timeline, early budget and enrollment warning signs, school leadership/recruitment; SBE meeting notifications/appearances; unlawful proposed merger; board and administrator instability, inexperienced/resignations, new hired administrator; academics failure, SBE accreditation status probation; steps to begin sponsorship termination proceedings per required Charter School Act statute 3-137; and presented reasons to terminate due to fiscal management standards, good cause violations of law defined in sponsorship contract; test scores, noncompliances of state/federal law, Oklahoma Constitution; indebtedness, finance, fiscal audits; and dissolution of a Charter School.

Mr. Clark recommended termination at the end the 2022-2023 school year, June 30, 2023, to begin March 23, 2023, and ending of the 90-day period for due process and appeal.

Board members asked questions and discussed the status Sovereign Community School with Kendra Wilson-Clements, School Board President, and Allison Black, newly hired School Leader that included professional backgrounds; Sovereign Community School affiliations, 2022 board appointment, inadequate school system setup, leadership, operations, internal controls, policies/procedures, inexperienced staff; new school leader credentials, academic turnaround, finance, 90-day recovery opportunity, academic accountability; financial contributions/stability, and tribal participation; require corrective action, monthly updates and progress reports through the end of the 2022-2023 school year.

Mr. Jett said questions were moving toward discussions and advised to take appropriate motions to continue.

Board member Williams Bradley moved for 90-day notification period and provide Sovereign the opportunity to have a hearing in March to showcase, what she hoped to be vast improvement to produce a high-quality learning environment for the students. The work they are doing, she believed, is important but also believes the board should not compromise quality to continue to go down the path it has been going down. Board member Superintendent Hofmeister seconded the motion.

Mr. Jett advised for clarity Board member Williams Bradley's motion is for the board to vote on whether to issue the Notice of Termination. The school would have 90 days to request an informal hearing on the termination decision, then come back to the board, at which time representatives from the department and Sovereign would present. The Notice of Termination will be issued today if the motion is approved.

Board member Hernandez called for Point of Order if the Notice of Termination vote failed the school will have corrective action opportunity.

The motion failed with the following votes: Mr. Smith, nay, Ms. Williams Bradley, yes; Ms. Hernandez, nay; Ms. Lepak, nay; Mr. Bobek, nay; Ms. Monies, nay; and Superintendent Hofmeister, yes.

#### (Superintendent Hofmeister called for a break at 2:49 p.m. and returned at 3:02 p.m.)

Further discussion concluded with clarification of the "Notice of Termination" will be the 90-day period. Mr. Jett advised if agenda item 7(c) is tabled with a majority vote, any future board requirements for the school could appear on the January 26 agenda.

Board member Hernandez moved to table agenda item 7(c) to the January 26, 2023, State Board meeting. Board member Bobek seconded the motion. The motion carried with the following votes: Mr. Smith, yes, Ms. Williams Bradley, nay; Ms. Hernandez, yes; Ms. Lepak, yes; Mr. Bobek, yes; Ms. Monies, yes; and Superintendent Hofmeister, nay.

Mr. Jett advised an Executive Session for agenda items 8 (a) and (b) was not required.

She was grateful for the impact on all our kids statewide, in her life, and watching her lead as a young woman leader.

Superintendent Hofmeister said she was appreciative and grateful for each member. Serving has been a lot of fun and such important work. She was grateful to walk alongside all, as we served, hashed out and came away unified in the mission and aim to serve kids in Oklahoma; and seeing they have the best education we can give them. Thank you very much!

Board member William Bradley seconded the motion. There motion carried by unanimous vote to adjourn at 4:21 p.m.
