

ORDER DECLARING ANNEXATION

Whereas, on the 18th day of October, 2022, concurrent resolutions for the annexation of all of the Greenville Public Schools (43C003), of Love County, Oklahoma, to the Marietta Public Schools (43I016), of Love County, Oklahoma, were delivered to the Oklahoma State Department of Education and;

Whereas, the State Superintendent of Public Instruction, published a call for an election for approval of such annexation by the eligible school district electors, which said election was given as prescribed by law, and;


Whereas, said annexation was approved at an election held on January 10, 2023, by a majority of the school district electors eligible to vote, and voting at said election, the vote being 51 for approval and 13 against approval of said annexation.

Whereas, all of the Greenville Public Schools property, facilities, assets, liabilities, debt, and equipment, etc., known or unknown, will become the property of the Marietta Public Schools on the effective date of this annexation.

All that Part of Sections 1, 2, and 11, Township 7 S, Range 2 E, Indian Meridian, Love County, Oklahoma, lying N and W of the centerline of Oil Creek. Township 6 S, Range 1 E. All of Sections 1, 12, 13, 24, 25, and 36, Township 6 S, Range 1 E, Indian Meridian, Love County, Oklahoma. All that part of Sections 2 and 11, Township 6 S, Range 1 E, Indian Meridian, Love County, Oklahoma, lying E of the centerline of Hickory Creek. Township 6 S, Range 2 E. All of Sections 4, 5, 6, 7, 8, 9, 15, 16, 17, 18, 19, 20, 21, 22, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, Township 6 S, Range 2 E, Indian Meridian, Love County, Oklahoma. All that Part of Sections 3, 10, 11, 14, and 23. Township 6 S, Range 2 E, Indian Meridian, Love County, Oklahoma, lying W of the centerline of Anadarche Creek, portions now submerged in Lake Murray. All that part of Sections 25 and 26, Township 6 S, Range 2 E, Indian Meridian, Love County, Oklahoma, lying W and S of centerline of Hickory Creek. Township 6 S, Range 3 E. All that part of Sections 30 and 31, Township 6 S, Range 3 E, Indian Meridian, Love County, Oklahoma, lying W of the centerline of Hickory Creek. Township 7 S, Range 3 E. All that part of Section 6, Township 7 S, Range 3 E, Indian Meridian, Love County, Oklahoma, lying W of the centerline of Oil Creek.

It is hereby **ORDERED** and **APPROVED** by the State Superintendent of Public Instruction, that the **entire** Greenville Public Schools of Love County, Oklahoma, be annexed to the Marietta Public Schools of Love County, Oklahoma, as indicated above.


