Bonnie McBride called the meeting to order at 1:15 p.m.

## **Monitoring**

Todd Loftin discussed the department's findings and plans for monitoring in the Spring. Mr. Loftin also shared a new proposal for new regulation regarding what can be involved in seclusion/restraint.

### **Certification Pathways**

The department is also working on four different pathways – tied to CEC standards – that would allow for more certification opportunities for special education teachers. The pathways would be 1) generalist, 2) mild/moderate, 3) severe/profound, and 4) comprehensive. Blind/Visual Impairment and Deaf/Hard of hearing would remain separate.

# **Paraprofessional Training**

The department is expanding the paraprofessional training opportunities to include professional development modules online and increased in-person training.

## Ginger Elliott-Teague (OSDE): APR Indicator Targets and SSIP Planning

Ginger Elliott-Teague shared that the Office of Special Education Programs (OSEP) has extended the current SPP/APR for another year. This is under the condition that states set targets for relevant indicators for FFY 2019. The preference of the Oklahoma State Department of Education – Special Education Services is to maintain FFY 2018 targets. The new SPP/APR expectations are to be issued in 2020 for State discussion and target setting.

The current State Systemic Improvement Plan (SSIP) involves 1) the assignment of STNs to SoonerStart for transition to Part B, 2) the incorporation of results-based training for parents and educators, 3) assistive technology and accommodations training for parents and educators, 4) early literacy training for educators, and 5) early literacy training for parents of 3 to 5 year olds.

The end date of the current State Systemic Improvement Plan (SSIP) is December 31, 2019. The final report is due April 2020.

## **Bonnie McBride: Panel Goals for 2019-2020**

Bonnie McBride shared the panel's goals for the 2019-2020 school year. They are 1) teacher retention/recruitment, 2) behavior, and 3) trauma informed schools – focus on students with disabilities.

The panel then divided-up into small groups to discuss questions such as 1) how can schools support teachers so that they remain in the special education classroom and 2) how can professional communities be developed in schools that support special education teachers?
