#### CALL TO ORDER

State Superintendent Ryan Walters called the State Board of Education regular meeting to order at 9:46 a.m. Ms. Cheadle called the roll and ascertained there was a quorum.

#### STATE SUPERINTENDENT

#### Information from the State Superintendent

Superintendent Walters welcomed everyone to the meeting and led Board Members and all present in the Pledge of Allegiance to the American Flag, a salute to the Oklahoma Flag and Prayer.

Superintendent Walters expressed concerns on the tragic assassination attempt of former President Donald Trump, inappropriate comments and threatening gestures made by Oklahoma teachers, school consequences for students displaying hatred behavior, State of Oklahoma cannot allow advocating assassination of a President of the United States, candidate or any elected official; update on Bibles in the classroom directive/guidelines/enforcement, and school district accountability; school districts directed to track cost and impact of illegal immigration, OSDE forthcoming guidance to ensure accurate accounting cost and burden on taxpayers and state.

#### ACCREDITATION STANDARDS

Presentation from Tulsa Public School District, discussion, and possible action on the Tulsa Public School District accreditation status for the 2022-2023 school year

Dr. Ebony Johnson, Superintendent, Tulsa Public School District (TPS) said greetings from Tulsa Public Schools (TPS), students, families, and Board of Education. Thanked Stacy Wooley, President, TPS School Board for her presence and team members Dr. Kathy Dodd-Deputy Superintendent, Sean Berkstresser-Executive Director of Information and Analytics, Joe Jennings-Chief Information and Operations Officer and new team member, Kristin Stevens-Chief Financial Officer. Due to the hard work of TPS, multiple schools collaborated to remove barriers for students, made warm welcome centers around the students, and excited TPS qualified for the United States Department of Agriculture (USDA) Community Eligibility Provision Program to provide worry-and-payment free student breakfasts and lunches. The program supports in multiple ways, helps collaborate with families, and removes barriers for students to attend school without any challenge.

Over the past year and course of this year, specific initiatives and investments were made to improve TPS student outcomes. The team member report highlighted important structural changes and shifts made to improve across the system, and ways to meet OSDE expectations outlined to improve TPS, and presentation included executive leadership team; consistent, high-quality instruction and resources to teachers; school organization and leadership, Leader Spotlight video: Dr. Rob Kaiser, Principal, Monroe Demonstration Academy, service improvement and high expectations; and concluded how TPS operates as a system, TPS culture and 2024-2025 non-negotiables.

Board members congratulated TPS team on job well done, complimented on continuation of excellent work, providing details of the future, showcasing the data process, best practices, and successes.

Superintendent Walters thanked TPS for their continued hard work, appreciated Dr. Johnson for keynoting the Inspire OK Conference and sharing implemented best practices; thanked board member Burdick for emceeing the conference and dedicated work with TPS; and TPS empowering administrators, data driven decisions, teacher guidance, resources, and trainings.

# TEACH and LEARN, SPECIAL EDUCATION-FEDERAL

# Presentation on the proposed revisions to the Policies and Procedures Handbook for Special Education Services

Sherri Coats, State Program Director for Special Education Services, presented overview of the proposed revisions for the Special Education policies and procedures handbook. The Office of Special Education is governed by the federal Individuals with Disabilities Education Act (IDEA) to provide public education to student with disabilities; OSDE is state agency responsible and authorized to implement and supervise IDEA statewide. The revisions were required by 2023 and 2024 legislation and agency policy amendments, public comment, and public hearing. Recommendations for approval will present at the August 22, 2024, State Board of Education regular meeting.

#### LEGAL SERVICES

Monthly report on complaints filed, and status thereof, regarding alleged violations of 70 O.S. § 24-157 and Administrative Code Rule 210:10-1-23, prohibiting race and sex discrimination

Michael Beason, General Counsel, State Department of Education (OSDE), advised an injunction issued by a court of competent jurisdiction with regard only to portions of the HB1775 statute 70 O.S. § 24-15. The injunction included striking the final sentence paragraph A1 from paragraph B1 striking the words require, striking letter B1 is C and D. It is concluded that there are still significant portions of the statutes that can be enforced by the agency and have shared my opinion with all in the chain of command that deals with enforcement. Norman Public School District submitted a request yesterday regarding a violation about an assignment pursuant to or about the word 'awoke'. Currently, we are ensuring we accommodate for a separate hearing and a mutually

agreeable time and place with the public school. This is the first type of hearing of this nature OSDE has had and will need to make sure it is completely in compliance with agency rules and fair to the district as well. A report will be provided once agency evaluation is completed.
