The meeting reconvened following publisher presentations. Chair designee Rebecca Morales communicated that there were bid sheet updates for specific vendors and bid items related to confirmed receipt of publisher bid samples. The amended bids are for the vendors Carnegie Learning, Cengage Learning, and Vista Higher Learning. Rebecca Morales told the Committee she would email the amended changes to all members.

Chair designee Rebecca Morales reminded members to review ISBN information for current bid items to be sure that bid items are exclusive to the current adoption cycle and not existing as an adopted item on previous lists.

Committee members Olivia Ehle and Teresa Gerber asked Chair designee Rebecca Morales for clarification of supplementary bid items. Chair designee read the Oklahoma Administrative Rule (OAR) 720:10-1-2 for the definition of supplementary and the directions provided to bidding vendors.

Teresa Gerber requested additional clarification of the definition for the term comprehensive. Rebecca Morales read aloud OAR 720:10-1-2 for the definition of comprehensive. Rebecca Morales also read aloud the first sentence of § 16-102(F) that "The Committee shall select textbooks or series of textbooks for each subject, which, to the greatest extent possible, are aligned with the subject matter standards adopted by the State Board of Education pursuant to Section 11-103.6 of this title."

Kathryn Yarbrough asked what the next steps for Committee members were following publisher presentations. Rebecca Morales explained that Committee members could begin evaluating the instructional material samples according to the subject-specific rubrics approved by the Committee except for the out-of-cycle bid items that do not yet have a subject-specific rubric available. Rebecca Morales further explained the out-of-cycle bid items without a Committee-approved subject-specific rubric are evaluated with the criteria defined by OAR 720:10-5-3. The criteria defined by this rule is included in an online evaluation tool to document the evaluation and Rebecca Morales will email to all Committee members after the meeting.

The last item on the agenda was adjournment of the July 19-22, 2022 STC meeting and Publisher Presentations. Joniece LeValley made a motion to adjourn the meeting at 12:02 p.m. Melissa Pearce seconded the motion. Vote was called.
