ORDER DECLARING ANNEXATION

Whereas, on the 9th day of January, 2020, a joint resolution for the annexation of all of the Greasy School District (C032), of Adair County, Oklahoma, to the Dahlonegah School District (C029), of Adair County, Oklahoma, were delivered to the Oklahoma State Department of Education and;

Whereas, the State Superintendent of Public Instruction, published a call for an election for approval of such annexation by the eligible school district electors, which said election was given as prescribed by law, and;

Whereas, said annexation was approved at an election held on June 30, 2020, by a majority of the school district electors eligible to vote, and voting at said election, the vote being 83 for approval and 61 against approval of said annexation.

Whereas, all of the Greasy School District's property, facilities, assets, liabilities, debt, and equipment, etc., known or unknown, remains to be determined, but will become the property of the Dahlonegah School District on the effective date of this annexation.

Legal Description: The east half of Section 11; Secions 12 and 13; the east half of Section 14; the east half of Section 23; Sections 24 and 25; the East half and the southwest quarter and the south half of the northwest quarter of Section 26; the south half and the south half of the north half of Section 27; the south half and the south half of the north half of Section 28; the south half of Section 30; Sections 31, 32, 33, 34, 35, and 36, all in Township 14 North, Range 24 East, Adair County, Oklahoma and Section 3; Section 4; the south half and the south half of the north half of Section 5; Sections 6; 7; 8; 9; 10; 15; 16, 17; 18; 19; 20; 21; 27; 28; 29; 30; 31; 32; 33 and Section 34, all in Township 14 North, Range 25 East, Adair County, Oklahoma.

It is hereby **ORDERED** and **APPROVED** by the State Superintendent of Public Instruction, that the **entire** Greasy School District (C032) of Adair County, Oklahoma, be annexed to the Dahlonegah School District (C029) of Adair County, Oklahoma, as indicated above.
