CALL TO ORDER AND ROLL CALL

State Superintendent Joy Hofmeister called the State Board of Education special meeting to order at 1:00 p.m. Ms. Cheadle called the roll and ascertained there was a quorum.

Superintendent Hofmeister welcomed everyone to the virtual meeting of the State Board of Education.

STATE SUPERINTENDENT

Recognition of Department Employee for the month of March

Superintendent Hofmeister recognized Alyssa Griggs, Assistant Executive Director, Accountability for outstanding leadership, professionalism and going above and beyond in meeting the needs of children, school districts and OSDE.

Information from the State Superintendent

Superintendent Hofmeister announced Jessica Eschbach an Innovative Learning Coach was selected as the 2021 Teacher for the Year (TOY) on March 4, 2021. Ms. Eschbach teaches technology integration at Norman Public Schools. News and updates included N95 masks gifted by anonymous donor were distributed to all Oklahoma public schools. Oklahoma State Department of Education (OSDE) and Oklahoma Department of Emergency Management and Homeland Security partnered with school safety officers and local emergency managers in the distribution. The OSDE allocated \$49 million in federal relief dollars to 88 school districts who received limited funding of the second round Elementary and Secondary Schools Emergency Relief (ESSER) allocations based on Title I funds. Districts that received less than \$550 per student in federal funds were awarded a portion of the \$49 million in additional funding; Elevate video highlight introducing "OpenSciEd" a free Kohler cam resource and OSDE participating in a nine states pilot program for middle school science, and a high school version coming in the fall.

Board members asked questions and discussed correction action process, community engagements, accreditation status change timeline; July 1 start date for new Superintendent and appear at the July or August SBE meeting. School district was requested to provide community engagement involvement in the next quarterly report.

The motion carried with the following votes: Ms. Williams Bradley, yes; Ms. Hernandez, yes; Mr. Flanagan, yes; Mr. Bobek yes; Ms. Monies, yes; Mr. Smith, yes; and Superintendent Hofmeister, yes.

Oklahoma Public Charter Schools Association v. State Board of Education

Board member Smith said I would like to make a motion regarding Item 5G, as in golf, to adopt a board resolution with all public schools and charter schools by settling the lawsuit of Oklahoma Charter School Association.

Superintendent Hofmeister said and before we have a vote, it is open for discussion or questions. I would like to say at this point, based on legal advice, this violates Oklahoma statute, Oklahoma Constitution, and the oath that I swore to uphold when I took office, and I do not support this, nor do I think the Board should vote to approve the settlement which came in yesterday. Are there any other questions or comments? Seeing none, please call the roll.

The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, nay; Mr. Flanagan, nay; Mr. Bobek yes; Ms. Monies, yes; Mr. Smith, yes; and Superintendent Hofmeister, nay.

Western Heights Public Schools

Board member Monies moved that the State Board of Education hereby expresses the utmost concern of the operation decisions and outcomes at Western Heights Public Schools, including but not limited to the following failure to provide in-person instructional services to students since the March 2020 determination in the spring of 2020 to not provide nutritional food to students.

The Audit report reflected violations of state law, including the use of 2018 bond proceeds voted by the taxpayers for the purposes of constructing and repairing facilities to repay debt in 2009 and 2013 Board Member consuming alcohol during a public meeting.

The majority of school sites are federally designated as in need of increased student support and school improvement, significant student loss of student enrollment from 3003 had to 65 students to 2597 students in the last year. A loss of more than 100 school personnel in the last two years and disharmony in the school environment and community.

As such, the State Board of Education finds orders and determines the Western Heights Public Schools administration be put on notice that it shall appear at a special meeting of the State Board of Education on April 9, 2021, whereby it may be subject to action on its accreditation status including, but not limited to a warning, probation or not accreditation.

The State Department of Education shall conduct a compliance and performance review of the school's operation, performance and outcomes, and the district is strongly encouraged to offer in-person instructional delivery option for families on or before April 1, 2021.

Board member Flanagan seconded the motion.

Board member Hernandez I have a comment. I would request, if at all possible, for Ms. Monies to be able to rephrase everything I agreed with what you just read, including all of those complaints that have been done by parents and other administrators. However, at this point, when we were sworn in as Board Members, we were given to abide by the also to uphold the Constitution. According to that law book, when there is an accreditation or a possible compliant of a school that may lose the accreditation, there has to be an investigation of the complaints first and then be presented to the Board.

And if anyone wants to look that up, that's on section 35. I agree that we need to go ahead and come to an agreement on this, but until SDE goes about it the right way and doing a full investigation because you have not given the school district the ability to come before us to be able to bring evidence against or for we have not done our due diligence either. If we can keep everything in that motion but just putting a period and asking them to come on April 9, 2021.

Board members Monies said I will just say I definitely respect that Estela, I will press the motion knowing that it says may, there accreditation may, I want to emphasize we have a long list of things that we find very troubling that are happening in the school district. We want to hear from them, so that is definitely what we are asking for here today. And I want to emphasize in the motion that all it is saying is that we may consider their accreditation at the special meeting where they appear April 9. I will press the motion as is.

The motion carried with the following votes: Ms. Hernandez, yes; Ms. Williams Bradley, yes; Mr. Flanagan, yes; Mr. Bobek yes; Ms. Monies, yes; Mr. Smith, yes; and Superintendent Hofmeister, yes.
