State-identified Measurable Result (SiMR)

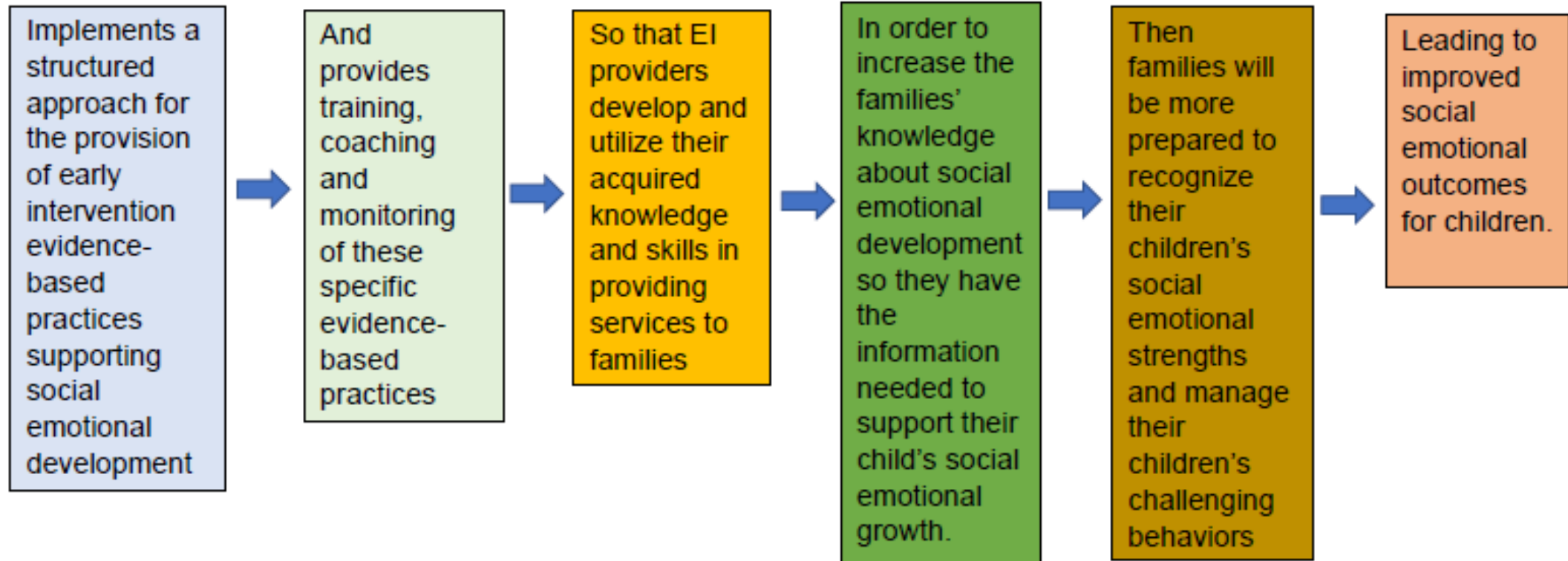
Oklahoma SoonerStart will increase the percentage of infants and toddlers who demonstrate positive social emotional skills.

Number of children scoring below cut-off on the ASQ:SE-2	Number of Children assessed using ASQ:SE-2	FFY 2020 Data	FFY 2021 Target	FFY 2021 Data
61	105	58.06%	58.00%	58.09%

The SiMR was measured by assessing all children at the Pyramid Model implementation sites who received at least six months of IFSP services

SoonerStart will provide training, coaching and monitoring of specific PM evidence-based practices

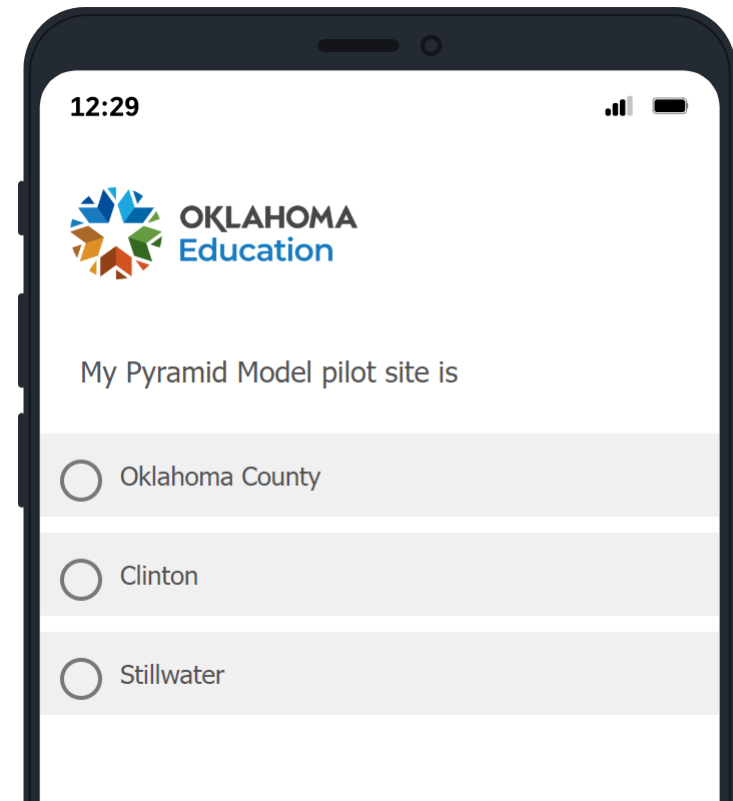

FAMILY ENGAGEMENT OUTCOMES

Families' knowledge about SE development will increase to support their child's SE growth.

--Caregivers demonstrate knowledge of SE development shared through program implementation of PM EBPs and other activities.

Families will recognize their child's SE strengths and manage challenging behavior successfully.

-- Caregivers report successful management of children's challenging behavior and identification of strengths.

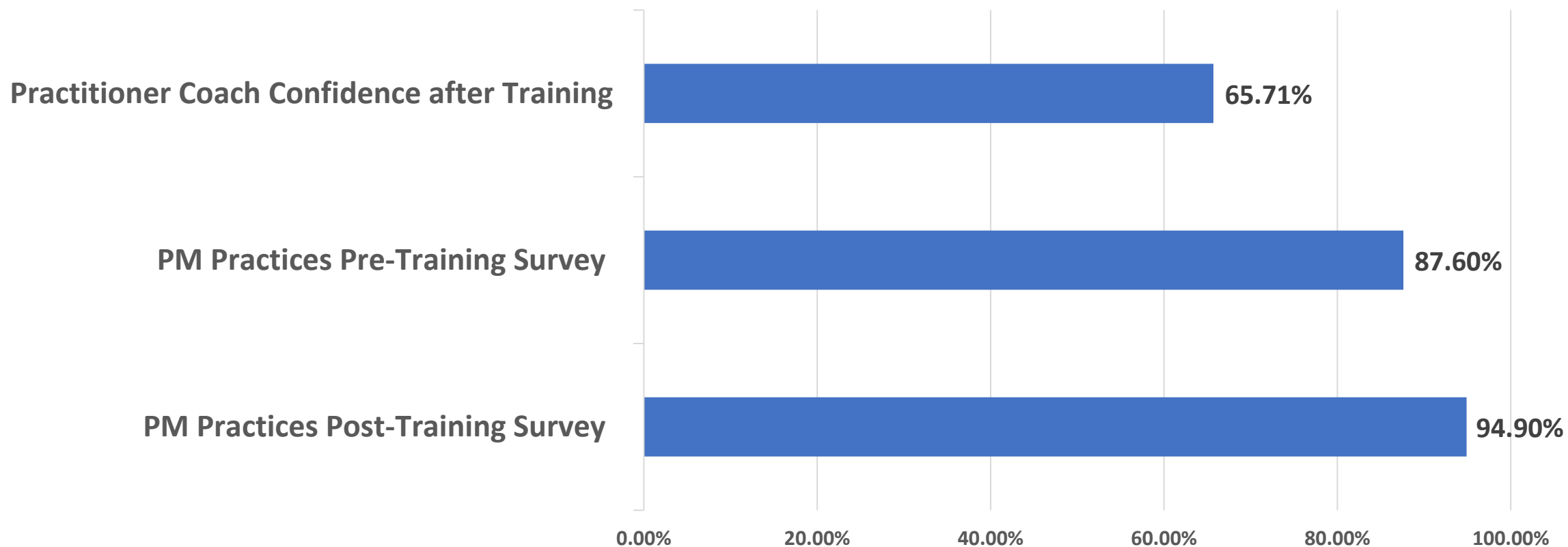

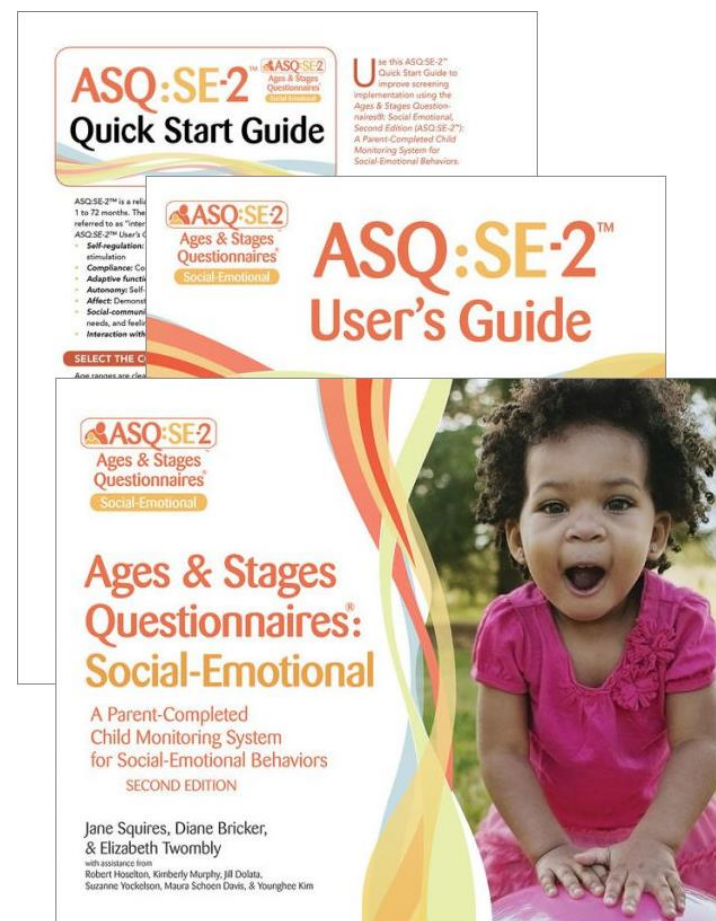

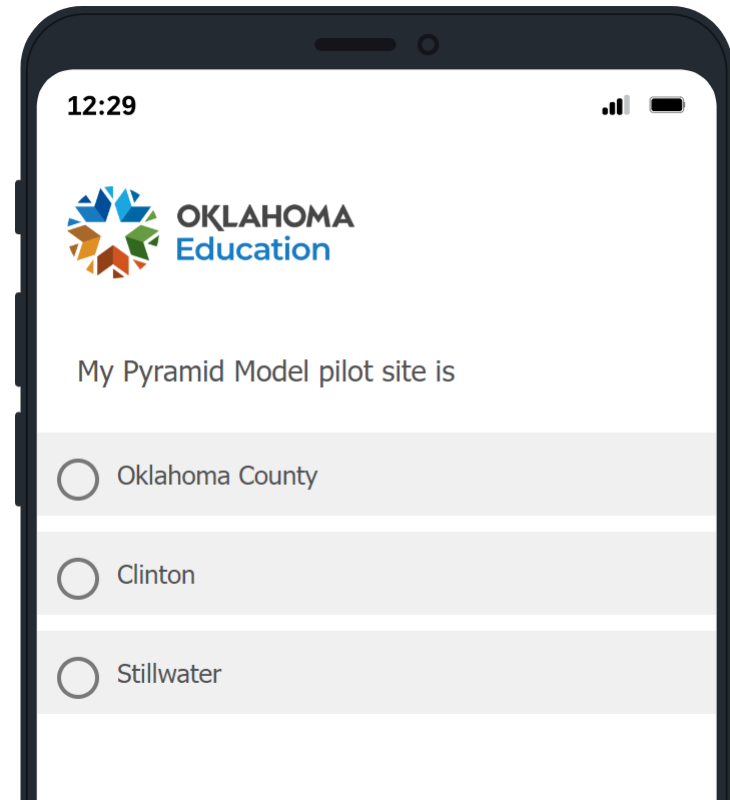
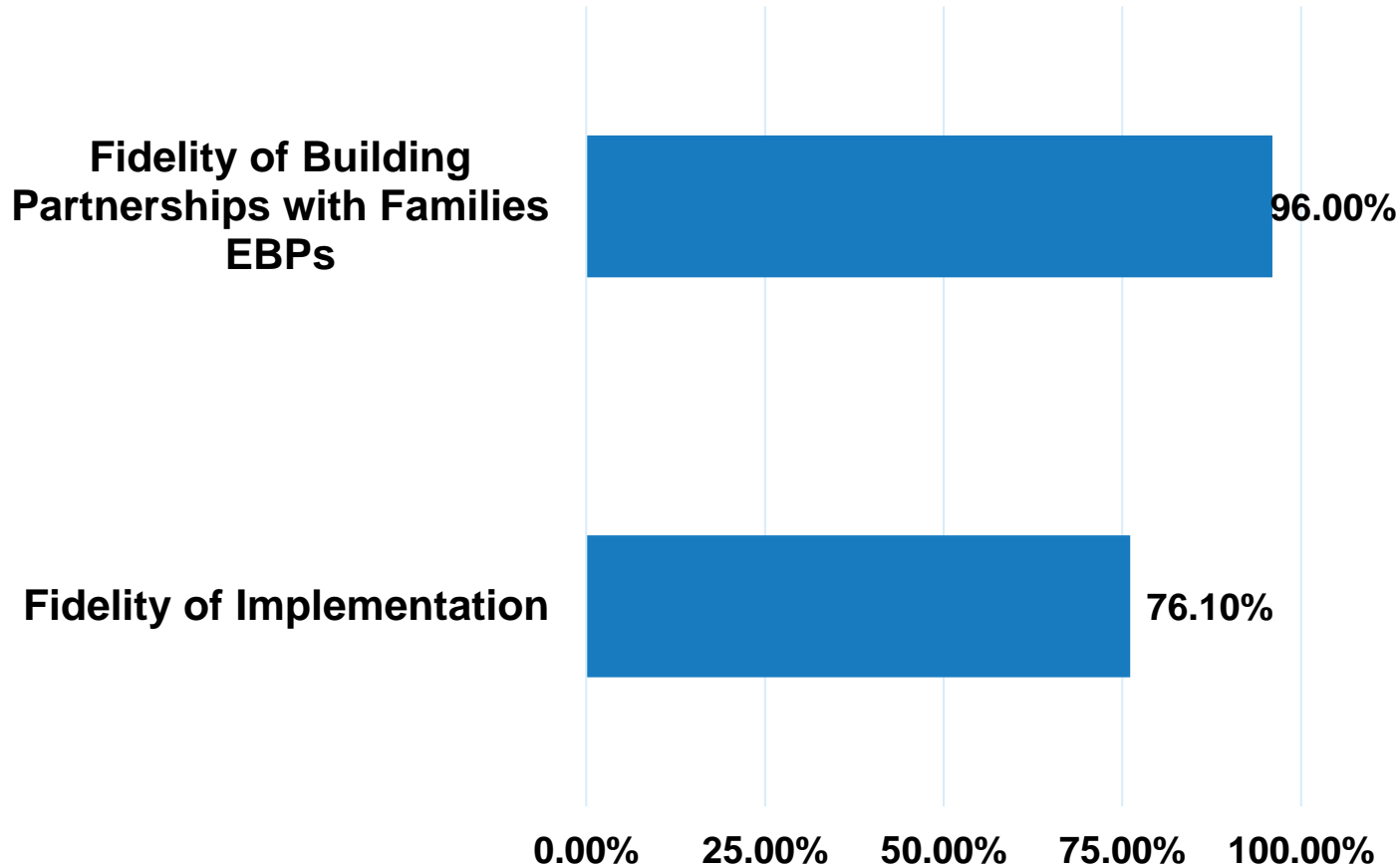


Ages & Stages: Social-Emotional 2

29.5% of the children at the Pyramid Model implementation sites who had an ASQ:SE2 completed at intake, and were assessed again with the ASQ:SE2 after six months of IFSP services had improved scores.

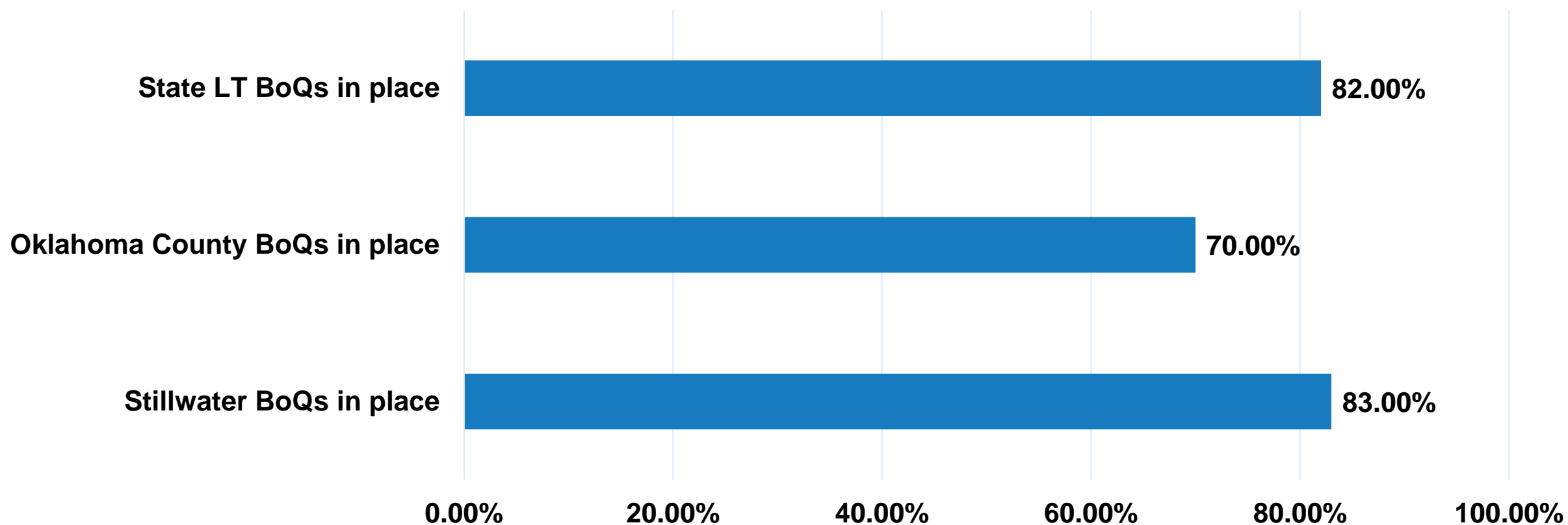


Early Intervention Implementation Checklist (EIIC)

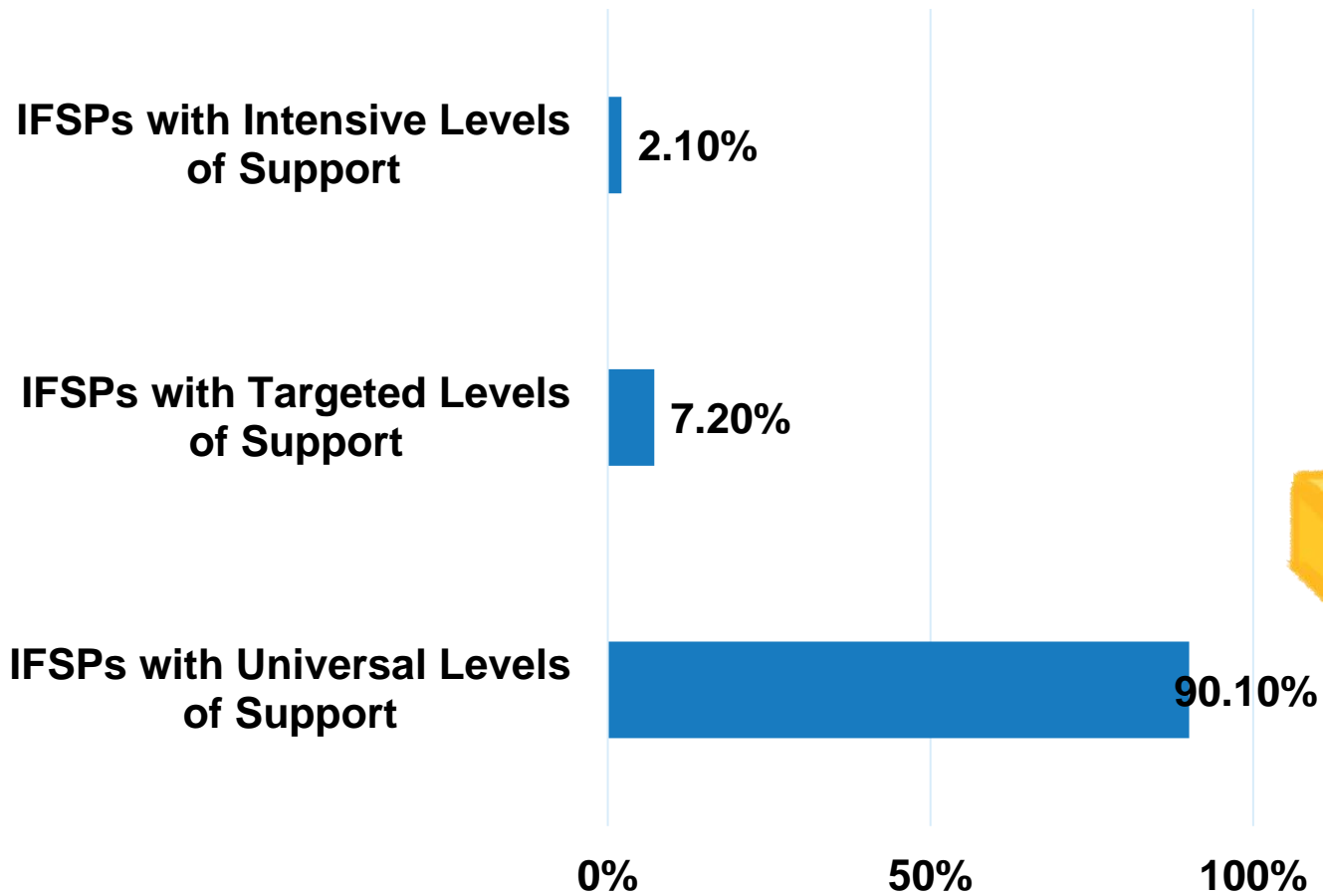


Pyramid Model Benchmarks of Quality

IFSP Tiers of Support



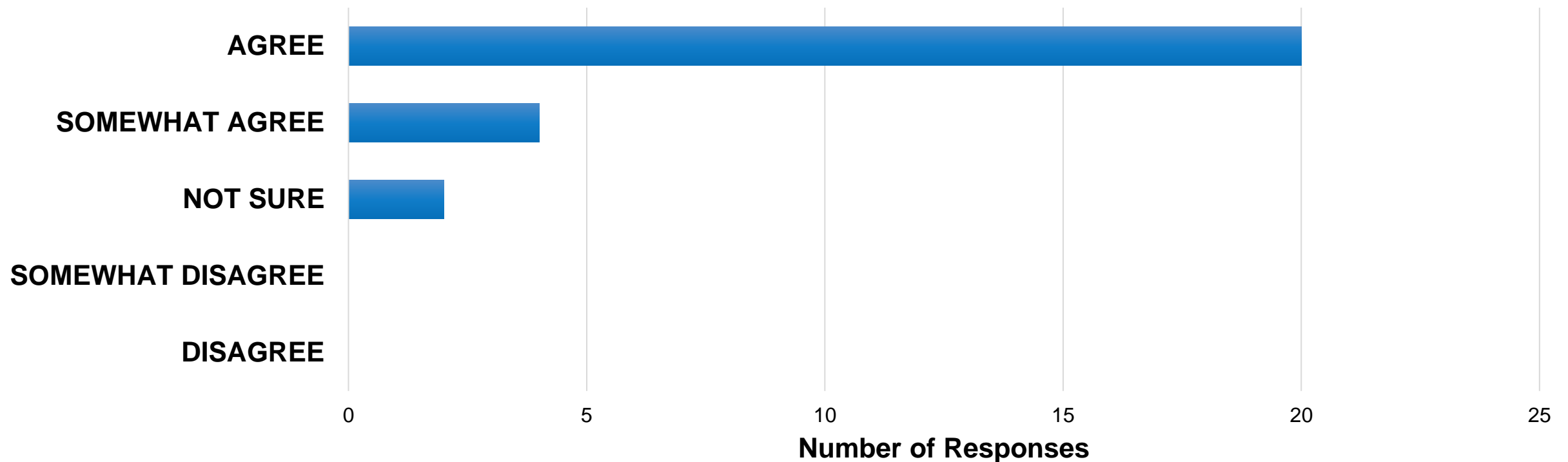

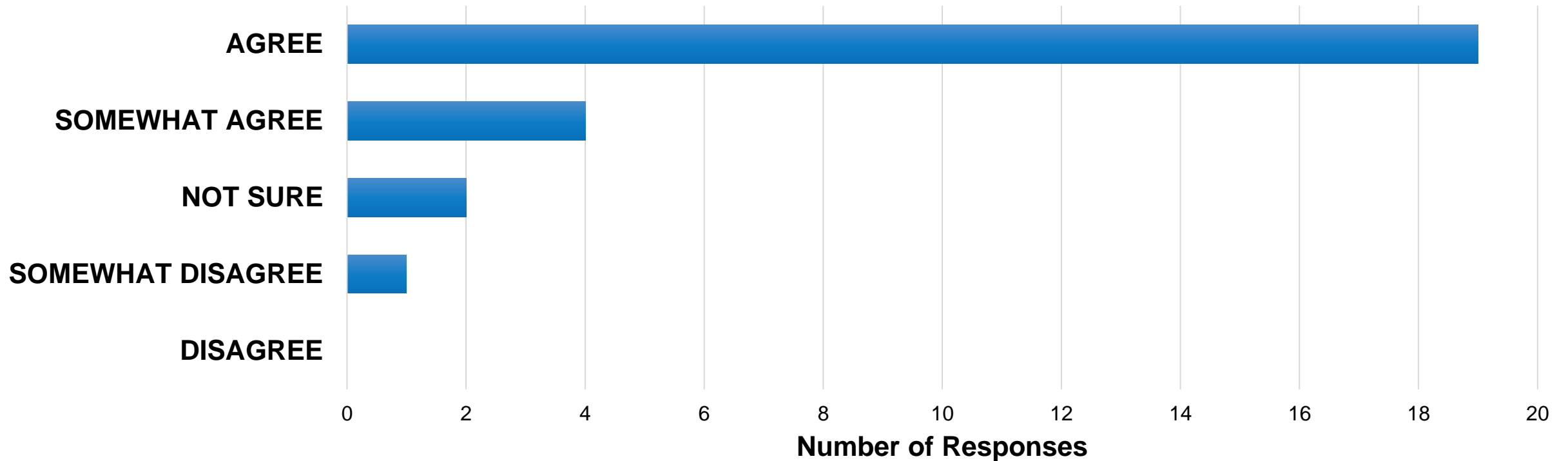
Stakeholder Survey – Frequency of Meetings

I am satisfied with the frequency of SSIP stakeholder meetings during the year (between 4 and 6 annually).



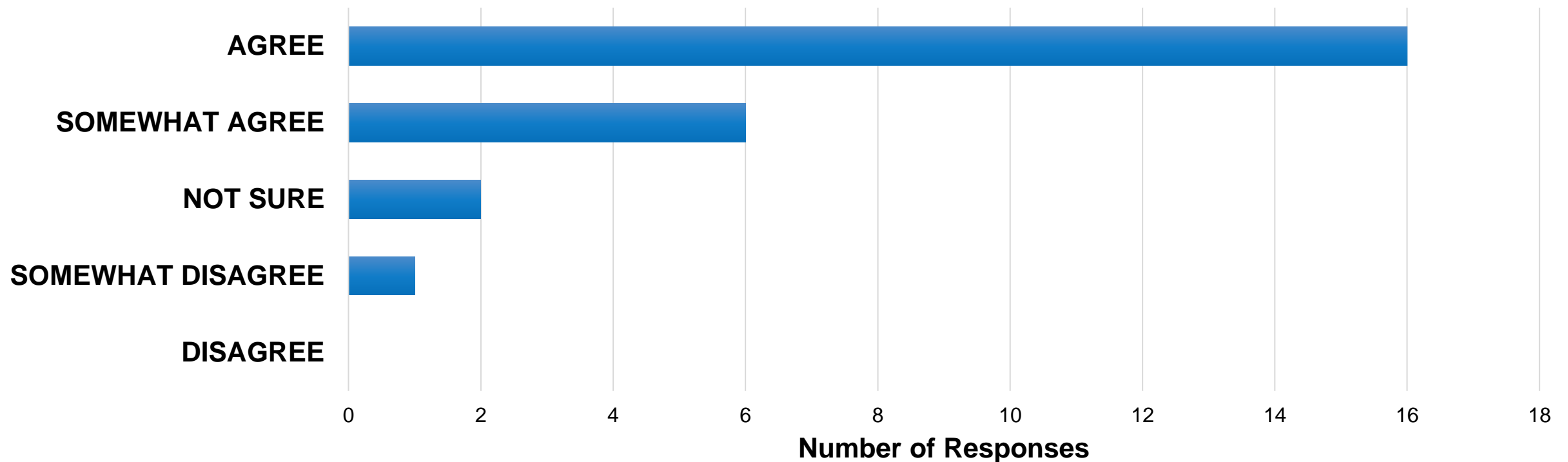
Stakeholder Survey – Quality of Communication

I am satisfied with the quality of communication I receive about APR/SSIP activities.



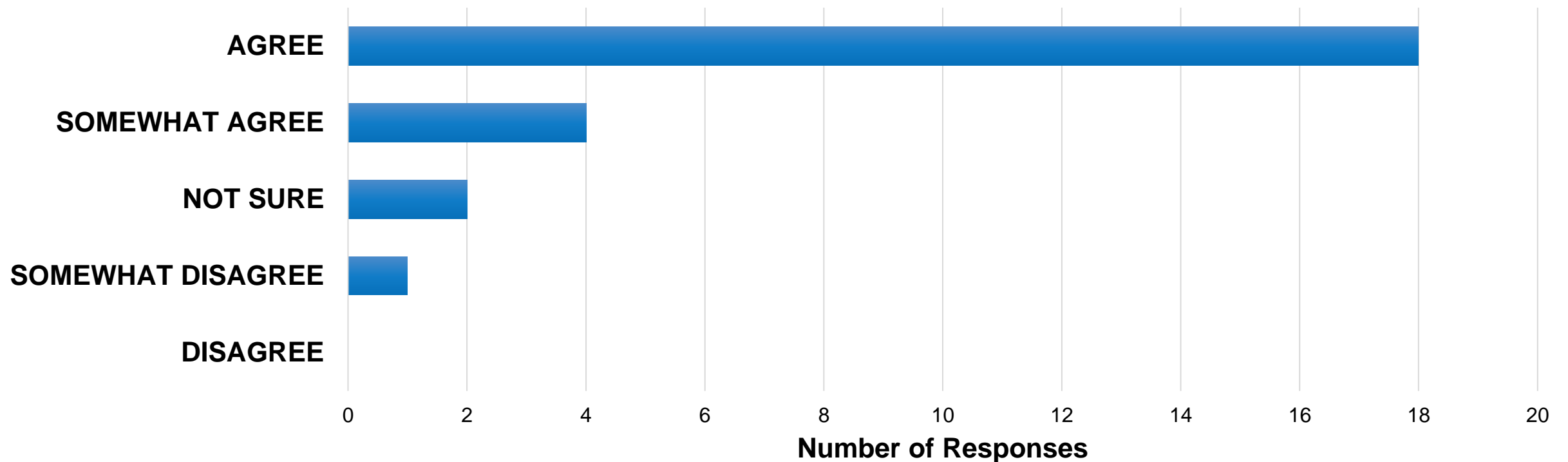
Stakeholder Survey – Presentation of Information

Information about SoonerStart’s implementation of the Pyramid Model is presented in a way that is easy to understand.



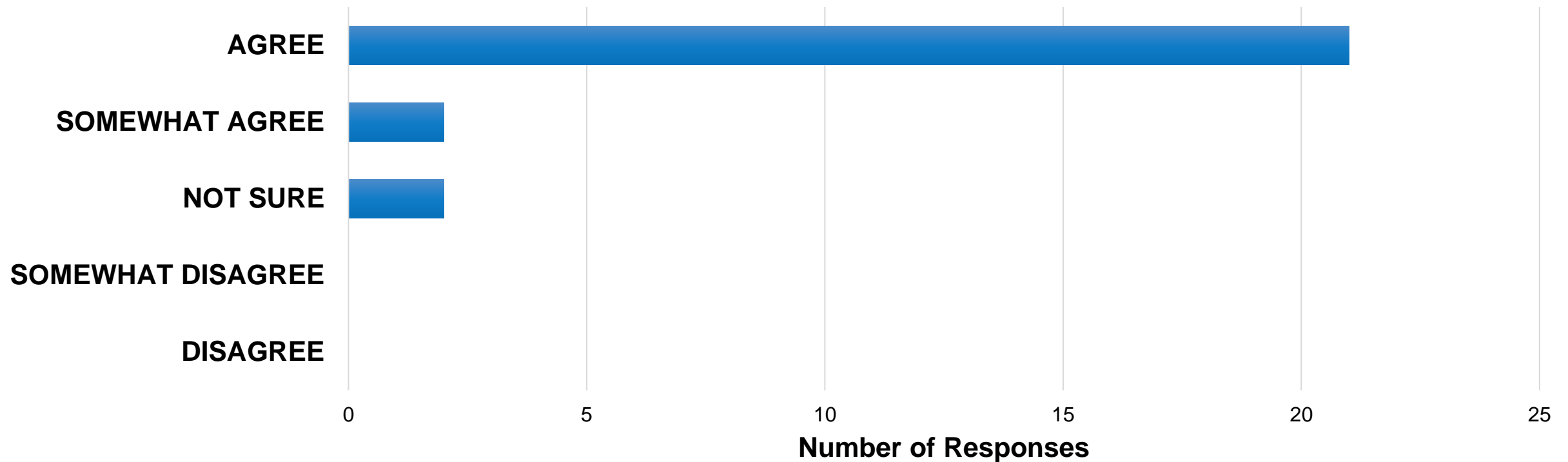
Stakeholder Survey – Stakeholder Participation

SoonerStart makes me feel that my participation in stakeholder meetings is important.



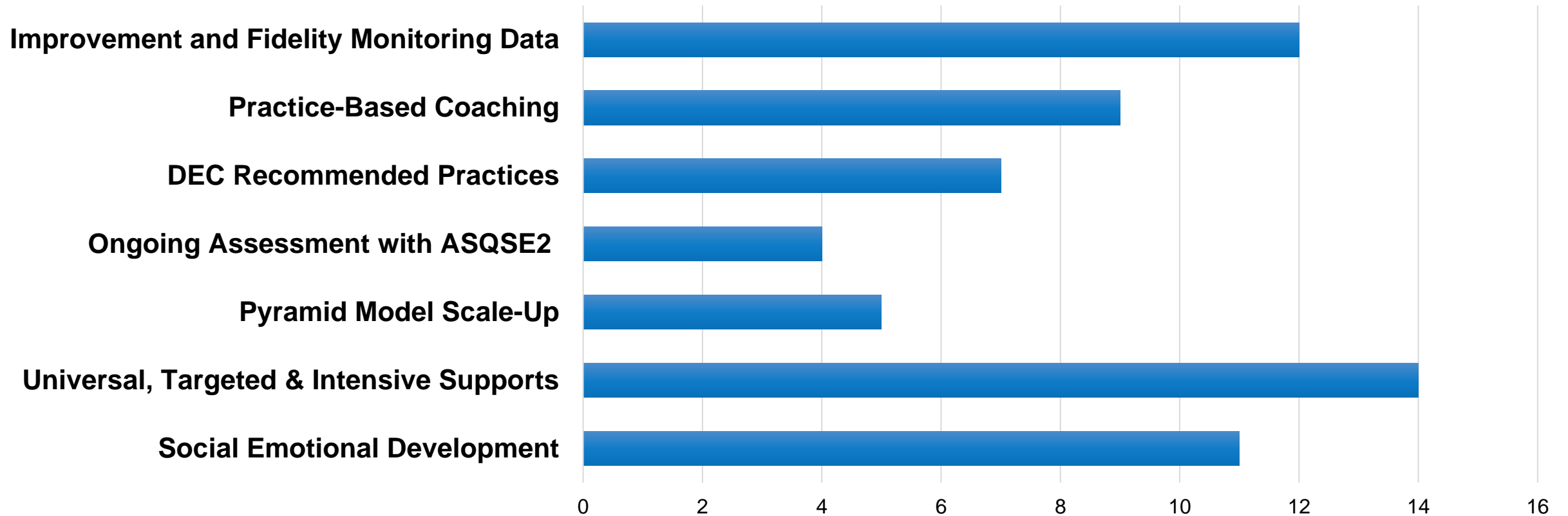
Stakeholder Survey – Stakeholder Input

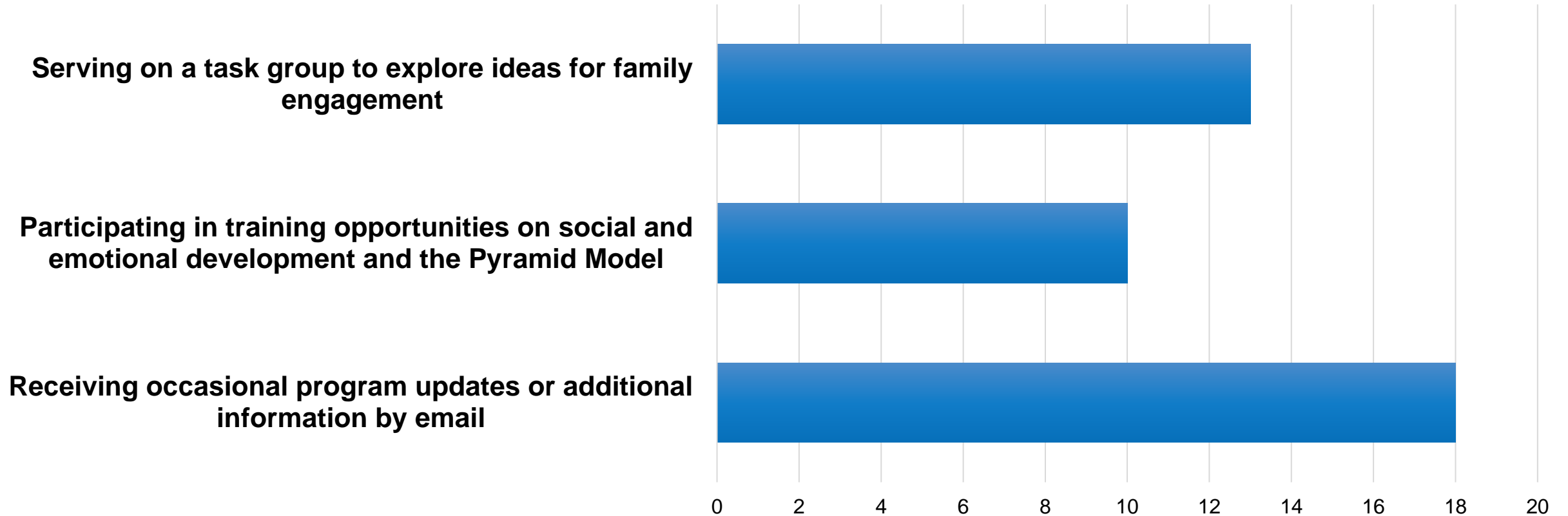

Definitions

SSIP - State Systemic Improvement Plan

SIMR – State-identified Measurable Result

Pyramid Model – a social-emotional learning framework

Service Provider – any staff member, regardless of role, at the Pyramid Model Pilot Site (i.e. Speech Pathologists [SLPs], Physical Therapists [PTs], Resource Coordinators [RCs], etc.)

Practitioner Coach – A service provider who has volunteered to be trained as a coach to other staff in supporting Pyramid Model evidence-based practices.

Program Coach – SoonerStart administrators who work with local pilot sites to provide support and technical assistance
