SoonerStart Early Intervention Program

- Provides services to eligible infants and toddlers (ages 0-36 months) statewide.
- Funded through yearly state and federal appropriations and Medicaid.
- El services are voluntary and provided at no cost to families regardless of family income.







Annual Performance Report (APR)

- Required by IDEA
- Submitted to OSEP each February for previous fiscal year (ex: July 21-June 22)
- Compares program data to state and federal targets for 11 indicators to measure performance of Part C program
- Requires extensive reporting on State Systemic Improvement Plan (SSIP)
- Used to issue a "Determination" to the state (i.e., meets requirements, needs assistance, needs intervention)




APR Indicator 4 – Family Outcomes

- Indicator 4 % of families who report that EI services have helped their family:
 - Know their rights
 - Effectively communicate their child's needs
 - Help their child develop and learn



SoonerStart Family Survey



SoonerStart partners with the Oklahoma Parent Center to collect information through a family survey.

Surveys are:

- anonymous
- offered at initial & annual IFSP meetings
- completed online, via telephone or by mail



Family Survey Response Rate

For Indicator 4, SoonerStart is required to:

- Report the number of surveys distributed and the number of responses from families participating in Part C
- Compare the current year's response rate to the previous year's response rate

Identify Potential Non-Response Bias

...Analyze the response rate to identify potential nonresponse bias

All families are given an opportunity to complete a survey at each initial and annual IFSP meeting and submit it anonymously. However, SoonerStart does not know the demographic characteristics of families that do not respond making it difficult to identify nonresponse bias.



Family Outcomes – and there's more...

Beginning with the FFY 2022 SPP/APR, due February 1, 2024, all states will be **REQUIRED** to report the extent to which the demographics of the infants or toddlers for whom families responded are representative of the demographics of infants and toddlers enrolled in the Part C program.

States must include race and ethnicity in it's annual analysis and also include another demographic category.



Family Outcomes – the good news...

SoonerStart currently reports three categories of demographic information.

- Race/ethnicity required in 2024
- Child's age
- Gender

SoonerStart proposes to continue reporting these same additional categories in order to avoid redesigning the Family Survey to meet the new requirements.

What is the Pyramid Model?

The Pyramid Model is a service delivery framework that contains a foundation and three increasing levels of support.

The Pyramid Model framework promotes young children's healthy development and decreases challenging behaviors.

Effective Workforce

 The Foundation supports professional growth of SoonerStart staff through coaching and professional development.

Nurturing & Responsive Relationships and High-**Quality Supportive Environments**

 Family coaching is provided to families to help them support their child's developmental growth.

Targeted supports

· Targeted supports are added to family coaching for some families needing a little more support to address a specific concern.

Intensive Interventions

· Intensive interventions are provided to a small number of families needing a detailed plan of action to address challenging behaviors.

SoonerStart staff will use the Pyramid Model framework to support families and children in reaching their developmental milestones.

Empowering families using the Pyramid Model

- Information to help families promote children's self-regulation
- Partnership with the Early Interventionist to help children learn & grow
- Support for preventing and addressing behavior challenges
