Re: Keyes Public School ("Keyes" or "the District"), Independent School District No. C-021, Cimarron County (the "District")

Superintendent Burgess,

I am writing to notify you, in your capacity as a superintendent of Keyes Public Schools, that the State Board of Education (the "Board") will consider the possible non-accreditation and/or mandatory annexation of the District at its May 28, 2020, meeting. The proposed effective date for mandatory annexation is June 30, 2020.

Oklahoma law provides that a school district may be annexed to one or more other districts through "mandatory annexation by the State Board of Education." *See* 70 O.S. § 7-101. Pursuant to this statute, the Board has promulgated administrative rules governing procedures for a mandatory annexation. *See* 70 O.S. § 7-101.1. At Oklahoma Administrative Code ("OAC") 210:1-3-2, these regulations provide that mandatory annexation will be considered by the Board in the following situations:

- 1. When a school district has been declared academically at-risk under the statewide system of accountability pursuant to 70 O.S. §§ 1210.541-545;
- 2. When a school district is non-accredited by the Board;
- 3. When a district fails to open or maintain a school, except when situations beyond the control of the district cause a normal delay. *See* OAC 210:1-3-2.

In the current situation with the District, OSDE is advising the Board that each of these triggering conditions is present. The gravamen of the recommendation for non-accreditation and mandatory annexation is based primarily on the District's increasingly low and unsustainable student enrollment, which has resulted in the District being unable to maintain an operational and legally functional public school. Moreover, as a result of the low enrollment, the public and

stakeholders at large are unable to verify the effectiveness of the District's academic offerings. Finally, as noted by the Board when placing the District on probationary accreditation status on February 27, 2020, the District is subject to non-accreditation for failure to maintain compliance with applicable laws and regulations relating to instruction, civil rights laws for students with disabilities and at-risk students. As presented to the Board in February, 2020, the District's student information data shows a significant trajectory of declining enrollment over the past several years, evidenced by student enrollments as of October 1 of each year. Specifically, the District's enrollment is summarized in the table below. In recent years, as a result of the low enrollment, Keyes has not provided transportation for students and has entered cooperative agreements with neighboring districts for students to participate in sports. The District's enrollment counts in the last five years have plummeted, and have continued to decrease in recent months.

As a consequence of the low enrollment, the District's School Report Card that is required as a part of Oklahoma's school accountability system pursuant to federal and state laws reflects information on academic and related measures in **only 1 of 14 indicator categories**. For the 2018-2019 Oklahoma School Report Card, the District's results are as follows:

See 2018-2019 Oklahoma School Report Card, Keyes Public Schools, pursuant to 70 O.S. § 1210.545. For the 2018-2019 school year, there were a total of nine (9) students who completed an assessment for the Oklahoma School Testing Program, which is used to calculate performance on certain of the accountability indicators. Because the school only had nine (9) students, the

District did not have the minimum number of students (the "N size") necessary to enable it to receive indicator grades on the School Report Card.<sup>1</sup>

Another consequence of the District's extremely low student enrollment—and resultantly low numbers of teachers employed—is a failure to offer the academic opportunities Oklahoma public school students are entitled to under state law. As a part of the legal and academic standards governing the accreditation of public schools by the Board, each high school must offer at least thirty-eight (38) units of study (or their equivalent in academic subject competencies) each year. See Oklahoma Administrative Code 210:35-9-31(g)(3). The 2017-2018 and 2018-2019 Accreditation Compliance Reports for Keyes High School indicate that the school did not offer the minimum of 38 units of high school credit required. See Accreditation Reports, attached as Exhibit "A." In practice, this deficiency means that students who live in the District are not offered the same opportunities as students in other districts to learn about a breadth of subjects at the high school level.

Similar to the impact that very low enrollment has on limiting the course offerings available for high school students, minimal enrollment has resulted in a lack of capacity to serve high risk students who live in the District. Under Oklahoma law, a student who is identified as being at risk of not completing their secondary education is entitled to alternative education services. *See* 70 O.S. § 1210.568; OAC 210:35-29-8. In 2019, Keyes' alternative education program was assigned a general rating of "Noncompliant" under the legally required annual evaluation of such programs, and received "Noncompliant" ratings for more than half of the specific program components. There were no Alternative Education program components in which Keyes was rated as "Highly Effective." What this means, in practice, is that a student who lives in the District and is at risk of not completing their high school education is less likely to receive services designed to help them achieve graduation than an at-risk student in another district.

In the circumstances outlined above, it is the obligation of the Oklahoma State Department of Education to recommend to the Board that it consider the non-accreditation and/or mandatory annexation of Keyes Public Schools at its next scheduled meeting on May 28, 2020.

Oklahoma law and administrative regulations provide that prior to the loss of a local school district's accreditation, the district and its representative will be given an opportunity to be heard before the Board. *See* OAC 210:1-5-5. Further, state law provides that when a recommendation for mandatory annexation is made, written notice must be provided to the board of education of the school district and said district may then request an opportunity to appear before the Board. *See* 70 O.S. § 7-101.1. As such, this letter shall serve as official notice that the Board will consider the non-accreditation and/or mandatory annexation of the District at its May 28, 2020, meeting.

The May 28 meeting of the State Board of Education will commence at 9:30 a.m. at the Oliver Hodge Building, 2500 North Lincoln Boulevard, Room 1-20, Oklahoma City, Oklahoma. At this time, pursuant to the authority granted in the Oklahoma Open Meeting Act, at 25 O.S. § 307.1, it is anticipated that the meeting will be held by videoconference. Should the District wish

to appear before the Board, please advise, and information specific to accessing and participating in the meeting remotely will be provided to you at a later date.

To the extent the opportunity to appear before the Board is requested, the governing statute provides that the Board shall "decide the issues after hearing from representatives of the school or school district and the State Department and shall make a final determination on the recommendation of the Department." *See* 70 O.S. § 7-101.1. Provided, however, that the District elects to not request an opportunity to address the Board, non-accreditation and/or mandatory annexation of the District will proceed without delay. In light of this notice and authority, the OSDE respectfully requests that the District advise whether it requests the opportunity to appear before the Board to address these matters.

Chapter 1 - School Code of 1971

Article Article VII - Annexation and Consolidation

ESection 7-101.1 - Rules and Regulations to Accomplish Mandatory Annexation or Consolidation - Notice

Cite as: O.S. §, \_\_\_ \_\_

A. The State Board of Education shall be authorized to promulgate rules and regulations regarding the procedures necessary to accomplish mandatory annexation or consolidation, as provided by and within the requirements of the provisions of Sections 2, 8, 9, 10, 11, 12 and 13 of this act, and as otherwise provided by law.

B. In any case where mandatory annexation of a school or school district is recommended by the State Department of Education, the Department shall notify, in writing, the board of education of the school district involved. Upon receipt of the notification, the school district board shall have fifteen (15) days to request an opportunity to appear before the State Board of Education. If the school district board fails to request an opportunity to appear, the State Board shall proceed without further notice or delay, to conclude the matter. If an opportunity to appear is requested by the school district board, the State Board shall decide the issues after hearing from representatives of the school or school district and the State Department and shall make a final determination on the recommendation of the Department.

## 210:1-3-2. Annexation, consolidation, dispensation, and severance determination

(a) **State Board of Education role.** The State Board of Education's role is: to receive and implement an order from the State Superintendent which declares that all or part of a district has been voted to be annexed, following statutory requirements, to adjacent or transporting district(s); to decide on the division of assets and property of a disorganized district in the event the problem cannot be resolved by the boards of annexing districts; and to set standards, promulgate rules and procedures, and conduct studies relating to the consolidation of two or more adjacent school districts. [70:7-105 & 106]

### (b) Mandatory annexation.

- (1) Mandatory annexation will be considered by the State Board of Education upon occurrence of the following situations:
- (A) When a school district has been declared "academically at-risk" pursuant to 70 O.S. 1989, §1210.541.
- (B) When a school district is nonaccredited by the State Board of Education.
- (C) When a district, without officially dispensing with school, fails to open or maintain a school (except when situations beyond the control of the district cause a normal delay). [Title 70 O.S. § 8-106].
- (2) When it comes to the attention of the State Board of Education that a local school district is facing the possibility of mandatory annexation, the State Board of Education shall provide the district with an opportunity to be heard. The State Board of Education shall notify the superintendent and each school board member of the time, date and place of the meeting. At the meeting, representatives of the school district, including patrons, shall have an opportunity to address the State Board of Education and to provide information to the Board. The President of the State Board of Education may set time limits on individual presentations and may require groups to select a representative to speak on behalf of the group.
- (3) When the State Board of education determines that a local school district is to be mandatorily annexed, the following steps will be followed:
- (A) The Board will notify one or more of the potential receiving districts that they are responsible for taking an inventory of property and securing the buildings and other property of the district being mandatorily annexed. In selecting the district(s) responsible for this procedure, the State Board of Education may rely on recommendations from the State Superintendent.
- (B) The State Board of Education will immediately notify the district superintendent of the Board's action.
- (C) The state superintendent shall notify the parents or legal guardians of all students in the district being annexed that they must apply for a transfer to the state superintendent within 10 days of the State Board of Education's action to annex. The state superintendent may require the parents to furnish a legal description of their residence at the time the transfer request is made.
- (D) Once the state superintendent has received the transfer requests, she/he shall notify the State Department of Education, in writing, of the breakdown of where students are asking to attend school by transfer and provide the State Department of Education with the legal description of the residence of each student.
- (E) The State Department of Education will utilize the transfer requests and legal descriptions submitted to the state superintendent as a guide in plotting the proposed boundary lines for dividing the annexed district. To the maximum extent possible, the preference of the students and parents shall be acknowledged.
- (F) The State Department of Education will present the proposed boundary lines for division of the annexed district to the State Board of Education for approval. The proposal shall be accompanied by the legal description of the property being annexed.
- (G) The assets and liabilities of the annexed district shall become part of the annexing districts. When an annexing district assumes a debt incurred by the annexed district prior to July 1, the district assuming the debt should receive a comparable portion of the assets.
- (H) When two or more annexing districts are involved in the division of an annexed district, the assets and liabilities are divided by agreement between the boards of education. If the boards of education are unable to agree, the matter shall be divided by the State Board of Education.

### (c) Consolidation of school districts.

(1) A petition by the board of education of any school district desiring a study of the consolidation of such school district with another school district or districts, or proposing such consolidation, shall be signed by the president and clerk of such board of education, and such petition shall be considered by the State Board of Education at its next

regular meeting. If a study of the proposed consolidation is deemed proper and advisable, the Secretary of the State Board of Education shall forthwith advise the boards of education of all districts involved that a study of the proposed consolidation is going to be made.

- (2) The State Board of Education reserves the right to make a study of the advisability of consolidating two or more school districts in any area of the State, on its own initiative, and without any petition from a board of education. When such decision is made, each school district involved shall forthwith be advised that such study is going to be made, and such districts shall be directed to determine, by such procedures as the State Board of Education may prescribe what, if any, consolidation should be carried on in the area under study.
- (3) All studies of the advisability of consolidation shall be under the direction of the President of the State Board of Education, who shall utilize the services of appropriate divisions of the State Department of Education.
- (4) If after a study of the population, wealth, terrain, trade areas and other pertinent factors, it is determined that two or more school districts should be consolidated, the board of education of each school district involved shall be so advised.
- (5) No election to determine consolidation shall be called or held unless there shall have been filed with the State Board of Education a petition therefore, signed by a majority of the school district electors of each school district included in the proposed consolidation. When such a petition is received and is determined to be sufficient, the State Board of Education shall call an election for the purpose of affording to the school district electors in the school districts involved an opportunity to express their wishes through a majority vote of the school district electors in the entire territory involved. Notice of such election, stating the time and date thereof and the polling places, shall be posted in five (5) public places in each school district involved, not less than ten (10) days before date of such election. Such election shall be conducted by one or more members of the State Department of Education, as designated by the President of the State Board of Education.
- (6) If a majority vote at such election is in favor of consolidation, the State Board of Education shall issue a written order to such effect, declaring the participating school districts dissolved and the new school district established. Copies of such order shall be sent to the county treasurer, county assessor and the county clerk of each county in which the districts involved are situated, and to the Oklahoma Tax Commission, and to the board Of education of each school district involved. If a majority vote at such election is not in favor of consolidation, the State Board of Education shall make a written order to such effect, and shall send a copy thereof to the board of education of each school district involved.
- (7) The local board of education members representing the school district having the largest number of enumerated children shall serve as board members of the newly-formed school district for the remainder of their term.
- (8) All liabilities, assets, powers and duties shall become the responsibility of the newly-formed school district.
- (d) Dispensing with a school district.
- (1) Should residents of a district desire to dispense with all or part of this school district, it is the duty of the State Superintendent to notify the State Board of Education of a majority vote of eligible electors at an annual or special election or by a petition signed by sixty (60) percent of eligible school district electors to dispense with either grades 1 thru 8 or grades 9 thru 12, or both, and such procedure shall be accomplished prior to June 30. Subsequently, parents of such children in the dispensed grades should file an application transfer for the ensuing year with the State Superintendent. Any district which dispenses with its entire school district for the ensuing year shall be mandatorily annexed on July 1 by the State Board of Education to an adjacent school district(s) to which pupils have been transferred.
- (2) Provided that if a school district does not officially dispense with its school following the preceding procedure and fails to open and maintain a school during such ensuing year, the State Board of Education, except as otherwise provided, shall at its next regular meeting annex such district, as provided by law. [70-8-106]
- (e) **Severance determination.** Pursuant to 70 O.S. §7-203(B), the State Board of Education may promulgate rules regarding its authority to budget and make expenditures of monies contained in the School Consolidation Fund. School Consolidation Funds can be used by annexing or consolidating districts to provide employment assistance in the form of severance for school district employees who are dismissed due to annexation or consolidation under 70 O.S. §7-203(B)(1)(c). The procedure for employees to make a severance application and process to receive a severance determination shall be communicated to all affected employees by the annexed or consolidated district superintendent. The severance application process is as follows:

- (1) To qualify for severance, district employees (teachers, administrators, and support personnel) must first seek severance allowance from the annexing or consolidating district(s) prior to making application to the State Department of Education.
- (A) Any annexing or consolidating school district(s) that receive School Consolidation Funds must accept and consider all requests for severance made by district employees who were dismissed due to annexation or consolidation, but not subsequently employed by the consolidating or annexing district(s).
- (B) The annexing or consolidating district(s) may elect to award qualifying employees a severance in an amount up to and not to exceed eighty percent (80%) of the individual's salary or wages, exclusive of fringe benefits.
- (C) Severance allowance from the annexing or consolidating district(s) is permissive in any amount from 0% to 80% of the individual's salary or wages, exclusive of fringe benefits, for the school year preceding the consolidation or annexation.
- (D) For the purposes of calculation, the district(s) shall include only the salary or wages actually paid to the employee for the school year preceding the consolidation or annexation.
- (E) Applications for severance shall be considered on an individual case by case basis.
- (F) Each district shall promulgate their own rules and procedures for accepting, reviewing, and awarding severance. The criteria used for awarding severance must be measurable, objective, non-discriminatory, and uniformly applied.
- (2) If the annexing or consolidating district makes an award of employment assistance in the form of severance, the district employee will not be eligible to make application to the State Department of Education for severance allowance unless the employee has also been denied unemployment compensation.
- (3) Unemployment benefits received by any district employee dismissed due to annexation or consolidation may be counted as a form of employment benefit under 70 O.S. §7-203(B)(1)(c). Unemployment compensation may be considered as part of the total employment assistance received and may be taken into account or offset when severance allowance determinations are made.
- (4) If a district employee is not employed by the annexing or consolidating district(s) and is subsequently denied severance or unemployment compensation by the annexing or consolidating district(s), pursuant to 70 O.S. §7-203(B)(1)(c), the district employee will be eligible to make an application for severance to the State Board of Education. Qualifying applicants shall receive a severance allowance from the State Board of Education pursuant to the following procedure:
- (A) Severance allowance from the State Board of Education shall be in an amount up to and not to exceed eighty percent (80%) of the individual's salary or wages, exclusive of fringe benefits. An award of a severance allowance by the State Board of Education will be made only if:
- (i) the applicant was not employed by the consolidating or annexing district and
- (ii) severance or unemployment compensation was denied at the district level.
- (B) Severance allowance from the State Department of Education can be in any amount from 0% to 80% of the individual's salary or wages, exclusive of fringe benefits, for the school year preceding the consolidation or annexation.
- (C) For the purposes of calculation, the State Department of Education shall include only the salary or wages actually paid to the employee by the district for the school year preceding the consolidation or annexation.
- (D) Only timely applications for severance received by the State Department of Education, Finance Division, will be considered. All applications for severance to the State Department of Education must be received no later than September 1 of the fiscal year immediately following the fiscal year in which the annexation or consolidation occurred. The application for employment assistance in the form of severance can be found on the SDE website, www.sde.ok.gov, or by contacting the State Department of Education, Finance Division.
- (5) Severance allowance by the State Department of Education can be denied only for good cause with supporting documentation of the following:
- (A) The applicant was hired by the consolidating or annexing district(s), regardless of the number of hours, part time or full time status, or rate of pay.
- (B) The applicant was dismissed or non-reemployed by the local school district board for reasons other than consolidation or annexation (i.e. reduction in force or inability to pay due to financial exigency),
- (C) The applicant received severance from the consolidating or annexing district(s) and in addition to unemployment compensation,

- (6) Severance allowance by the State Department of Education can be reduced or adjusted below eighty (80%) percent of the applicant's salary or wages, excluding fringe benefits, for good cause with supporting documentation. Good cause to reduce or adjust severance can include, but is not limited to, consideration of the following:
- (A) The annexation or consolidation was mandatory rather than voluntary.
- (B) The applicant's length of service to the district.
- (C) The applicant's service record, job performance, or conduct warrants consideration of a reduction or adjustment in severance. The application of this criteria must be supported by verifiable documentation and evidence that is made available for the Board's review.
- (D) The applicant was hired by the local school board after the annexation or consolidation election results are called by the State Superintendent of Public Instruction.
- (E) The applicant was hired by the local school board after the State Board of Education voted to non-accredit the district.
- (F) The applicant failed to apply for or make an attempt to gain employment with the consolidating or annexing district(s).
- (G) The applicant failed to apply for or attempt to obtain a severance allowance from the consolidating or annexing district(s).
- (H) The applicant received unemployment compensation. The amount of unemployment compensation received can be considered an offset when determining severance.
- (7) Severance Determinations. Upon receiving the application for severance the State Department of Education, Finance Division staff shall review the applications for severance and make a written recommendation to the State Board of Education regarding each severance application. Each severance application will be considered on an individual case by case basis and a recommendation for severance allowance or denial will be made by the SDE staff to the State Board of Education in writing during a regularly scheduled Board of Education meeting.
- (A) The applicant will be notified of the SDE staff recommendation and will be given written notice of the time, place, and date of the regularly scheduled State Board of Education meeting that the Board will consider and voting upon the SDE staff recommendation for severance.
- (B) The State Board of Education will vote on all SDE staff recommendations for severance in open meeting. All votes of the State Board of Education approving or denying a severance application will be considered a final order of the Board.
- (8) The applicant will be notified in writing of the State Board of Education's final determination regarding severance allowance. The applicant will have ten (10) days from the date the notification of severance determination is received within which time to file a petition for appeal or reconsideration of the Board's determination.
- (9) Any petition, reconsideration, or hearing on the Board's final order regarding severance shall be made pursuant to, and governed by, the Due Process Procedures of the State Board of Education as outlined in 210:1-5-1 of the Oklahoma Administrative Code.
- (f) **Guidelines and forms.** Copies of corresponding State Department of Education forms and guidelines for the implementation of annexations/consolidation and severance are available from the consolidation officer of the State Department of Education.

Superintendent Hofmeister and Members of the Oklahoma State Board of Education:

I am interested and concerned about the outcome of the pending annexation of the Keyes school district into another district or districts. I believe that I do have a rather unique perspective on the entire situation. I am a current and life-long resident of the Keyes district and I attended that school for my entire public school education, graduating with the class of 1981. My wife and one of my two daughters also graduated from the school. Also, I taught Junior High and High School science in Keyes for 19 years - from 1991-2010. In 2010, I was beginning to see that the student numbers were indicating a declining trend that has finally culminated in the situation that the school finds itself in at this time. When the student number problem became evident to me, I took an opportunity that presented itself in the neighboring district of Boise City. I taught both Junior High and High School science for 6 years, and then worked as a teaching principal in Boise City for the past 2 years. This year I was hired by the Boise City district to fill the role of Superintendent.

During my time at Keyes and Boise City, there has generally been healthy cooperation between the schools to try to provide the best possible opportunities for the students in both schools. Some years ago, there was a sports co-op in place that allowed Keyes boys to go to Boise City to play football and Boise City boys played baseball at Keyes. More recently Boise City has readily welcomed sports co-ops with the Keyes district in cross country, softball, basketball, track, and golf. The Boise City Board of Education has consistently made these activities available to our school neighbors to help the Keyes students have opportunities that they would not otherwise. In the last 3 years or so there has been a marked increase of students and teachers making the move from the Keyes district to Boise City. Currently there are 28 students enrolled in Boise City that reside in the Keyes district and 5 teachers have made the move as well. To my knowledge there have been no staff movements from Keyes to Yarbrough district and I am aware of only 1 student who lives in the Keyes district that now attends Yarbrough. That student's mother is a teacher in Yarbrough school, and I don't believe he ever attended school in Keyes.

Geographically speaking, Keyes is 15 miles from Boise City and 25 miles from Yarbrough. Keyes and Boise City are both in Cimarron County while Yarbrough is in Texas County. I point this out because I think there was some inadvertent misinformation at the February meeting of the State Board on this point. I think it also relevant that Yarbrough co-oped basketball this year with Hardesty - a district that is 69 miles from Keyes. Also, because I am a lifetime resident of the Keyes district, I have had multiple conversations with people in the district that do not want their tax dollars going into another county. Many of those same individuals are upset that the

Keyes school leadership did not make adequate efforts to determine the will of the district residents before proceeding with the annexation process. At this point the Keyes school leadership desires that the State Board of Education make a decision for them that they did not have the will to make.

It is my belief that there are some underlying sentiments against Boise City within some of the Keyes school leaders, and I think that has played a part in how this whole process has unfolded. Ultimately what should be the decisive factor in this decision should be the welfare of the few remaining students in the Keyes system. I can say unequivocally that the students that have transferred to the Boise City district from Keyes have been well accepted by both their student peers and all of our staff and faculty. Some of those students have done better than others in classes and activities, but that is of course true of the students who reside in our district as well. Boise City offers more educational and extracurricular opportunities than does Yarbrough. The second important factor that should weigh heavily in this decision is the will of the residents of the Keyes district. They should have a voice concerning where their school should be annexed. I do not believe there was much if any effort by the Keyes school leadership to determine the direction that the people of the district wanted to go in this matter. That just seems wrong to me.

In conclusion, I believe that Boise City is the best choice for the Keyes school to annex into for multiple reasons:

- 1. Already most transfers out of Keyes are enrolled in Boise City.
- 2. Boise City offers more academic and extracurricular opportunities than does Yarbrough.
- 3. Boise City is geographically closer.
- 4. Boise City is in the same county.
- 5. Boise City is the county seat of Cimarron County and many Keyes people go there for other purposes. Yarbrough has just a school on its site.
- 6. The vast majority of the current residents of the Keyes district would prefer annexation to Boise City.

We are writing on behalf of Yarbrough School District in regards to the possible closing of the Keyes School District. As an adjoining district, along with Boise City, we are interested in how Keyes might be dissolved and would like to share our views on the matter. First and foremost, it is our desire to be good neighbors throughout the process. We are not seeking to annex the entire district; however, we would like to respectfully request that Yarbrough be considered to receive a portion.


While Keyes is primarily considered a Cimarron county school district and Yarbrough is primarily considered a Texas county school district, each school does extend into the adjacent county. Yarbrough has approximately 58 square miles in Cimarron county, and Keyes has approximately 8 square miles in Texas county. We currently provide transportation to one family that lives in the Cimarron county portion of Yarbrough's district, and we would be willing to provide transportation services to any portion of Keyes that might be annexed to Yarbrough.

Currently, Boise City is approximately 1,070 square miles. Keyes is 372 square miles, and Yarbrough is 375 square miles. If combined, Yarbrough and Keyes would still be considerably smaller in area than Boise City. In considering the land area sizes of the districts in question, a possible division line could be set at county road N0430. Please see attached map. This division would add approximately 237 square miles to Yarbrough and 136 square miles to Boise City, with Boise City receiving the vast majority of the actual town of Keyes. If this division were used, we would like to request permission to bus from within the city limits of Keyes. We understand that there are only a few students that have remained at Keyes; however, we would appreciate the opportunity to be their school of choice and be able to offer them transportation to Yarbrough. We are extremely proud of our school and all that we have to offer our students, parents, and community members. Please see attached information.

It now appears the matter is in the hands of the State Department of Education to determine the annexation.

I believe that 28 students have transferred to Boise City School District over the past 3 years. Boise City School is 15 miles by car or bus from Keyes School. (Please see attached map). Whereas, Yarbrough School is 24 miles from Keyes School by car or bus. (Please see attached map). The town of Boise City is the County Seat of Cimarron County as well as the business center of the community. Yarbrough School is a rural school located on OK Highway 95 which is 7 miles east of the Cimarron – Texas County line in Texas County. Boise City has the county's only grocery store, a Dollar General, two convenience stores with fuel as well as many other businesses. The town of Keyes and the surrounding area **must** be annexed with the Boise City School District to avoid an academic and economic tragedy in Cimarron County.


I urgently and respectfully request that the State Board of Education perform due diligence to determine the destiny of this district. With the arrival of the COVID-19

virus, public meetings are not possible and public statements will not be a reality at your meetings.



### Joyce Balenseifen:

As our community deals with the trauma of our school closing, as a voter and taxpayer of the Keyes district I also want to have a voice in where my tax dollars go. I have visited with Marley a couple different times so i may be repeating some of the information i have.

A little background to help you understand the value i place on education. I am the parent of three sons, all graduates of the University of Oklahoma. My oldest graduated from Keyes in 2005, my middle son from Keyes in 2009 and my third in 2014 from Boise City. Our hard choice to move to the Boise City district in 2011 was made because the Keyes school, in my opinion, was failing to prepare my child for higher education. He spent his freshmen year in Algebra I playing cards and I am certain without the move, and a great math teacher who helped him catch up in math, his ACT scores would not have been high enough to be able to attend OU. Most of the parents i have visited with who have moved out of the Keyes school in more recent years also moved for education, citing uncertified teachers, lack of classes offered and no extra curricular activities. I was told there are 28 children living in the Keyes district that attend Boise City presently.

I want to be annexed into the Boise City District where the majority of the children who are residents of the Keyes district attend today. These same kids that i support in their extracurricular activities such as 4-H, Scouting and church activities. I called the Keyes School to find out what grades the students left there were in. I was told that all 5 of the high schoolers were talking the number of credits to graduate this year, the 2 jr high kids were going to be home schooled next year, the girl in elementary school already had a brother attending Boise City and the elementary boy has his dad and grandparents that live at Felt and is already playing elementary basketball there. I believe there will be none of these students that will attend Yarborough School next year.

In reading our local board minutes for the last several months, I see some 'discussion' items about the future of the school but no vote was recorded on annexation. I also see where our local superintendent Freida Burgess reports that she has heard nothing from the state. Yet in Mr Clark's remarks to the State Board at the February meeting, he says 1. 'The District Superintendent is well aware of and I believe she believes the district should close" and 2. "The Board members have discussed this but they do not want to make this decision, they would rather this body make this decision." His statements indicate to me that he had conversations with Freida Burgess. I believe the voters of this district have been denied their due process by this current superintendent and board. I respectfully ask for your decisions to be based on all the facts, the desire of the district people and not on a part time superintendent that does not live here and has not participated in our community.

#### Debbie Brown:

My name is Debbie Brown and I am a very new member of the Keyes school board of education. I have had several concerned citizens approach me regarding our up coming annexation which is happening as a result of our not meeting accreditation and the declining numbers of our student body.

Their concerns are mostly with how their opportunity to vote on a resolution about the school with which they would like to annex has been taken from them. I've spoken with Bryan Drummond the Keyes school legal counsel and Brandon Carey with the OSSBA on this matter and they both recommended the voters take part in an email campaign in hopes their voices can be heard.

I am sending this email asking that you please consider the voice of these voters as you move forward with the annexation decision.

On another note, if I understand correctly the Keyes board is to have an online meeting with the state board of education on Friday, April 17th. Several of these voters would like to attend if it is at all possible. They understand they will not be able to speak but there is a distrust between the voters and the Keyes board and they would like to hear about the meeting first hand if possible.

Respectfully I know our state board of education members have a very full plate and I would not be asking for any of your time if I didn't believe it to be of great importance that I speak with someone before the annexation decision is made. My contact number is 580.518.1860.

### Bob Cochran:

Mr. Clark,

I sent you a letter in mid March to express concerns about the annexation of the Keyes Public School district. I realize that our world was changing rapidly at that time and has certainly spun into a whole new level of chaos since then. I am concerned that my comments may have been lost in all that madness. I have included that original correspondence in this email, not in an effort to appear pushy or belligerent, but just to satisfy myself that you read those comments. I would very much appreciate an acknowledgement that you did receive this message and attached letter. Thank you!

### Mr. Clark,

I am interested and concerned about the outcome of the pending annexation of the Keyes school district into another district or districts. I believe that I do have a rather unique perspective on the entire situation. I am a current and life-long resident of the Keyes district and I attended that school for my entire public school education, graduating with the class of 1981. My wife and one of my two daughters also graduated from the school. Also, I taught Junior High and High School science in Keyes for 19 years - from 1991-2010. In 2010, I was beginning to see that the student numbers were indicating a declining trend that has finally culminated in the situation that the school finds itself in at this time. When the student number problem became evident to me, I took an opportunity that presented itself in the neighboring district of Boise City. I taught both Junior High and High School science for 6 years, and then worked as a teaching principal in Boise City for the past 2 years. This year I was hired by the Boise City district to fill the role of Superintendent.

During my time at Keyes and Boise City, there has generally been healthy cooperation between the schools to try to provide the best possible opportunities for the students in both schools. Some years ago, there was a sports co-op in place that allowed Keyes boys to go to Boise City to play football and Boise City boys played baseball at Keyes. More recently Boise City has readily welcomed sports co-ops with the Keyes district in cross country, softball, basketball, track, and golf. The Boise City Board of Education has consistently made these activities available to our school neighbors to help the Keyes students have opportunities that they would not otherwise.

In the last 3 years or so there has been a marked increase of students and teachers making the move from the Keyes district to Boise City. Currently there are 28 students enrolled in Boise City that reside in the Keyes district and 5 teachers have made the move as well. To my knowledge there have been no staff movements from Keyes to Yarbrough district and I am aware of only 1 student who lives in the Keyes district that now attends Yarbrough. That student's mother is a teacher in Yarbrough school, and I don't believe he ever attended school in Keyes.

Geographically speaking, Keyes is 15 miles from Boise City and 25 miles from Yarbrough. Keyes and Boise City are both in Cimarron County while Yarbrough is in Texas

County. I point this out because I think there was some inadvertent misinformation at the February meeting of the State Board on this point. I think it also relevant that Yarbrough cooped basketball this year

with Hardesty - a district that is 69 miles from Keyes. Also, because I am a lifetime resident of the Keyes district, I have had multiple conversations with people in the district that do not want their tax dollars going into another county. Many of those same individuals are upset that the

Keyes school leadership did not make adequate efforts to determine the will of the district residents before proceeding with the annexation process. At this point the Keyes school leadership desires that the State Board of Education make a decision for them that they did not have the will to make.

It is my belief that there are some underlying sentiments against Boise City within some of the Keyes school leaders, and I think that has played a part in how this whole process has unfolded. Ultimately what should be the decisive factor in this decision should be the welfare of the few remaining students in the Keyes system. I can say unequivocally that the students that have transferred to the Boise City district from Keyes have been well accepted by both their student peers and all of our staff and faculty. Some of those students have done better than others in classes and activities, but that is of course true of the students who reside in our district as well. Boise City offers more educational and extracurricular opportunities than does Yarbrough. The second important factor that should weigh heavily in this decision is the will of the residents of the Keyes district. They should have a voice concerning where their school should be annexed. I do not believe there was much if any effort by the Keyes school leadership to determine the direction that the people of the district wanted to go in this matter. That just seems wrong to me.

In conclusion, I believe that Boise City is the best choice for the Keyes school to annex into for multiple reasons:

- 1. Already most transfers out of Keyes are enrolled in Boise City.
- 2. Boise City offers more academic and extracurricular opportunities than does Yarbrough.
- 3. Boise City is geographically closer.
- 4. Boise City is in the same county.
- 5. Boise City is the county seat of Cimarron County and many Keyes people go there forother purposes. Yarbrough has just a school on its site.
  - 6. The vast majority of the current residents of the Keyes district would annexation to Boise City.

Thank you for your consideration and allowing me to share my thoughts and concerns with you in this matter.

My concern is that most of our students have transferred to Boise City already which is only 15 miles. I would want my ad valorem tax money to support those students instead of splitting it to Texas County with Yarbrough.

To Whom It May Concern,

Concerning the distribution of school funding that will become available at the closing of the Keyes School District in Cimarron County, we want to strongly urge you to consider allocating the funds to the Yarbrough School District, or, at least, divide the funds between the Boise City School District and the Yarbrough School District.

We are interested in the consolidation of Keyes School because we own property in the Keyes School District, so we are taxpayers/patrons for the district. We both grew up in Keyes, went to all twelve years of elementary and secondary school at the Keyes School, graduating in the classes of 1980 and 1981. We farm, raise cattle, raised and home educated our children in the Keyes community until 2014, when we moved away from Keyes. We did consider putting our oldest daughter into the public school when she entered high school, so we visited the Boise City, Keyes, Yarbrough, and Elkhart schools to consider our options. We ultimately decided to continue with our homeschool, but if we were in the position again to choose to send any of our children to a public school, we would earnestly desire a choice, based on our child's interests and personality. The Boise City School and the Yarbrough School are very different; thus, where one child might not be so successful at one school, that child might be very successful at the other.

In addition, the existing east side of the Keyes School District is a considerable geographical distance from Boise City. In fact, the Keyes School District consists of a tract of land in Texas County, so we think splitting the Keyes School District funds between Boise City School and Yarbrough School not only makes geographical sense, it also makes economic sense for that Texas County land, along with at least the eastern side of the existing Keyes School District to become part of the Yarbrough School District. The Boise City School District already expands all the way to the west and north ends of Cimarron County, and if the Felt School were ever to close, Boise City School would consist of the entire expanse of western Cimarron County.

**SUBJECT:** District Status Report – Keyes Public School

#### **District Status Report**

Information is being provided to the State Board of Education ("State Board") regarding Keyes Public School ("Keyes" or "the District"), based on a review of federal and state laws and regulations for public school programs, including but not limited to the accreditation of public schools in Oklahoma. Issues of concern identified during the review are addressed by program area below. Before addressing program areas, an overview of the District is provided.

#### I. The District

Keyes Public School is an independent school district in Cimarron County, serving students in Pre-K through 12<sup>th</sup> grade. Keyes' student information data appears to show a significant trajectory of declining enrollment over the past several years, evidenced by student enrollments as of October 1 of each year, the relevant reporting date. In recent years, as a result of the low enrollment, Keyes has not provided transportation for students and has entered cooperative agreements with neighboring districts for students to participate in sports.

See 2018-2019 Oklahoma School Report Card, Keyes Public Schools, pursuant to 70 O.S. § 1210.545. For the 2018-2019 school year, there were a total of nine (9) students who completed an assessment for the Oklahoma School Testing Program, which is used to calculate performance on certain of the aforementioned indicators. Because the school only had nine (9) students, the District did not have the minimum number of students (the "N size") to enable it to receive an Indicator grade(s) on the School Report Card.<sup>2</sup>

#### II. Accreditation

The Oklahoma Legislature, in recognizing its obligation to the children of the state and to ensure their opportunity to receive an excellent education, and recognizing obligations to taxpayers of the state, have established requirements for compliance with quality standards which the public schools must meet. *See* 70 O.S. § 3-104.3. These compliance requirements and quality standards are commonly referred to as the accreditation standards, governing the classification, inspection, supervision and accrediting of the public schools by and through the State Board. *See* 70 O.S. § 3-104(7); *see also* 70 O.S. §§ 3-104.3 and 3-104.4. Consistent with these requirements, the State Board has adopted administrative rules for accreditation of public schools, governing the operations, activities and supervision of public schools, as well as a school's compliance with applicable regulations and statutory requirements. *See* Oklahoma Administrative Code 210:35-3-201. The regulations provide for the accreditation status of a school to be classified according to the following:

- 1. Accredited With No Deficiencies--All standards are being met.
- 2. Accredited With Deficiencies--A school site fails to meet one or more of the standards but the deficiency does not seriously detract from the quality of the school's educational program.
- 3. Accredited With Warning--A school site fails to meet one or more of the standards and the deficiency seriously detracts from the quality of the school's educational program.

- 4. Accredited With Probation--A school site:
  - a. consistently fails to remove or make substantial progress towards removing all deficiencies noted the previous year; and/or,
  - b. consistently violates regulations; and/or,
  - c. deliberately and unnecessarily violates one or more of the regulations.
- 5. Nonaccredited--The school site is no longer recognized by the State Board of Education.<sup>3</sup>

#### A. Course Credits

As a part of the accreditation standards, each secondary school must offer and teach at least thirty-eight (38) units or their equivalent in academic subject competencies each year. *See* Oklahoma Administrative Code 210:35-9-31(g)(3). The 2017-2018 and 2018-2019 Accreditation Compliance Reports for Keyes High School indicate that the school did not offer the minimum of 38 units of high school credit required pursuant to *Oklahoma Administrative Code* 210:35-9-31(g)(3). *See* Accreditation Reports, attached as Exhibit "A."

The failure to offer the minimum required number of high school course offerings resulted in Keyes High School being assigned the 2018 accreditation status of "Accreditation with One Deficiency", and the continuing shortage of class offerings resulted in the 2019 accreditation status of "Accreditation with Warning."

It is the OSDE's understanding that the District continues to offer fewer than 38 units of high school credit during the 2019-2020 school year. In fact, the District may only offer approximately twenty-three (23) courses at the high school, which is the minimum number of units or competencies a student must complete in order to graduate. *See* 70 O.S. § 11-103.6; OAC 210:35-9-31.

#### III. Special Education

In 2018, the Oklahoma State Department of Education (the "OSDE") Office of Special Education Services investigated a complaint alleging that a 16-year-old student was being served under an out-of-date Individualized Education Program (IEP), and that the student was not being provided with the services to which they were entitled under the *Individuals with Disabilities Education Act* (IDEA).

The 2018 investigation concluded that Keyes Public School was in noncompliance with the requirements of the IDEA, specifically 34 C.F.R. § 300.101 ("Free Appropriate Public Education") and 34 C.F.R. § 300.324 ("Development, Review, and Revision of IEP"). See OSDE Complaint, attached as Exhibit "B." As a part of the District's corrective action, an assurance statement was signed, assuring that all IEP's are timely finalized and that all special education staff of the District are trained on IEP implementation timelines.

Despite the provided assurance statement, it appears that the District has failed to comply with the timelines and requirements of IDEA. To date, the District currently has three (3) children with disabilities and an IEP; however, two (2) of these are out of compliance with IDEA requirements. IDEA, and its corresponding federal regulations, require that a reevaluation of each child with a

disability occur at least once every 3 years, unless deemed unnecessary. See 34 CFR § 300.303. Upon review of District records, the last reevaluations conducted on two students was March 4, 2016 and January 17, 2017 such that without information in the file deeming the reevaluation unnecessary, the District is out of compliance.

#### IV. Alternative Education

A school district's alternative education program is annually rated using an Alternative Education Evaluation Rubric, to determine whether appropriate alternative education services are being offered to students as required by Oklahoma law. *See* 70 O.S. § 1210.568. The Alternative Education Evaluation Rubric lists 40 components of alternative education programs, with a possible rating for each of the 40 statements of "Noncompliant," "Minimally Compliant," "Effective," and "Highly Effective."

In 2017-2018, Keyes' alternative education program was rated "Noncompliant" in 2 alternative education components, and "Minimally Compliant" in 12 components. There were no Alternative Education components in which Keyes was rated as "Highly Effective."

Beginning in 2018-2019, the Alternative Education Evaluation Rubric changed format to eliminate "Minimally Compliant" status and provide for 3 levels of rating for each component rather than 4: "Noncompliant," "Effective," and "Highly Effective."

In 2018, Keyes' alternative education program was assigned a general rating of "Noncompliant," and received "Noncompliant" ratings for 25 specific components. There were no Alternative Education program components in which Keyes was rated as "Highly Effective." (The 2020 Alternative Education Evaluation Rubric for Keyes has not yet been completed.)

#### V. Annexation

Oklahoma law provides that a school district may be annexed to one or more other districts either through a local election held with the approval of the boards of education of the affect districts, or through "mandatory annexation by the State Board of Education." *See* 70 O.S. § 7-101. Pursuant to this statute, the Board is authorized to promulgate rules and regulations regarding procedures to accomplish mandatory annexation. *See* 70 O.S. § 7-101.1. At Oklahoma Administrative Code ("OAC") 210:1-3-2, administrative rules provide that mandatory annexation will be considered by the Board in the following situations:

- 1. When a school district has been declared academically at-risk under the statewide system of accountability pursuant to 70 O.S. §§ 1210.541-545;
- 2. When a school district is non-accredited by the Board;
- 3. When a district fails to open or maintain a school, except when situations beyond the control of the district cause a normal delay. *See* OAC 210:1-3-2.

Currently, evidenced by its significantly low student enrollment and less than minimal course offerings, nearly causing students to not have the opportunity to graduate, the District is on a trajectory – if not already – to fail to open or maintain school, be declared academically at risk and lose accreditation.

#### VI. Recommendation

In light of the foregoing, the OSDE recommends that the accreditation status of Keyes public schools be classified as "Accredited with Probation." Additionally, barring an extraordinary change in the District's student enrollment and course offerings, the OSDE recommends that Keyes Public Schools be mandatorily annexed, effective June 30, 2020. Pursuant to applicable laws and regulations, the OSDE recommends that appropriate notifications be provided to the District of the proposed annexation, as well as to neighboring school districts, and that a hearing be set on the proposed annexation as early as March 25, 2020.
